Guard Against Slips, Trips And Falls



Unfortunately we had a retrospective LTI last week where an employee slipped on some off cuts of reinforcing strand. The employee fractured a bone in his right ankle and has had to have time off work. **Everyone in CEMEX UK should believe that we all have the right to go home from work unhurt every day.**

Therefore it is all of our responsibilities to STEP IN and LOOK OUT FOR EACH OTHER every minute of every day.

As this incident and many others show slips, trips and falls are causing most of our serious incidents, this year good housekeeping on sites could have prevented many of these incidents from happening.

Especially as winter is nearly upon us it is important we do all we can to make sure our sites are hazard free by:

- Maintaining dedicated walkways (applying grit salt where required)
- Providing suitable lighting
- Using appropriate footwear (lace up ankle safety boots on sites)
- Getting a grip on steps/stairways
- Insisting on good housekeeping standards



Don't Drive And Use Your Mobile Phone



You may well have heard about the lorry driver who was jailed for 10 years last week for using his mobile phone (scrolling through his music selection) whilst driving and subsequently crashing into several stationary cars.

The pile-up seriously injured some and killed a mother and her three children as their car was concertinered under a stationary lorry to one third of its original size.

Perhaps something that makes this story even more chilling is the fact that the court heard that an hour before the pile-up the lorry driver had signed a declaration to his employer promising he would not use his phone at the wheel. Footage showed that the driver hadn't been concentrating on the road ahead for about 1km.

This horrific story highlights the need for us all to think before we use our phone whilst driving any vehicle. Our cars and lorries are potentially lethal weapons which we need to be fully in control of at all times.

Remember the CEMEX UK mobile phone policy?

Here it is:

- If it isn't urgent to make a call - don't!
- If you need to make a call pull over into a safe place before doing so.
- If it is absolutely necessary to make or take a call whilst driving, you must be on hands free and keep the call short and always put driving conditions first.
- If you call a mobile phone ask the person if it is safe for them to take a call. If they tell you they are driving ask them to call back when they have parked up safely.
- Texting, emailing, scrolling through music or any other hands-on use of mobile devices is illegal.

Do You Know About The Health & Safety Academy?



The Health & Safety Academy is a global CEMEX initiative which all Line Managers should have an opportunity to attend.

It is made up of three modules and is intended to further develop health and safety leadership skills and also raise awareness of the CEMEX Health and Safety Management System.

So far, in addition to hosting the Foundation Module, the trainer course for the Europe Region, the UK has held a further five courses involving 87 delegates including the Management Teams from each business sector. There is one more course planned before the year end.

Next year the UK are planning on running two Foundation courses a month from February onwards, as well as launching Modules 2 and 3.

Historic United Nations Climate Change Agreement

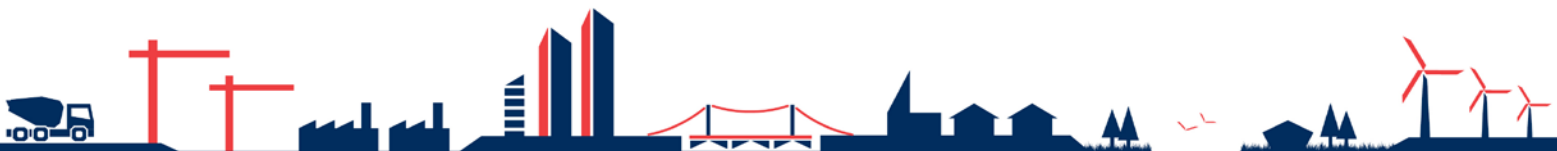


This week the cement sector celebrated the United Nations Paris Agreement coming into force. The agreement paves the way for more sustainable development and major reductions of CO2 emissions. The cement sector alone could potentially reach a reduction of around 1 giga tons (one billion tons) of CO2 emissions by adopting the agreements framework.

The Paris Agreement sets out a stable regulatory framework to help business community to scale up the implementation of low carbon solutions to help mitigate climate change.

This represents an historic moment. For the first time in UN history a worldwide, ambitious, legally-binding treaty has been ratified by enough parties to enter into force in less than one year after its official adoption. This demonstrates a clear change in the parties' commitment for all stakeholders to fight against climate change and its impacts.

CEMEX CEO currently chairs the Cement Sustainability Initiative (CSI) and Fernando Gonzalez, CEO of CEMEX, made this statement: *"Climate change is a global issue that no one can solve alone. The cement sector has been working collectively since 1999 on measuring and reporting its CO2 emissions while developing solutions for mitigation and adaptation through the CSI."*

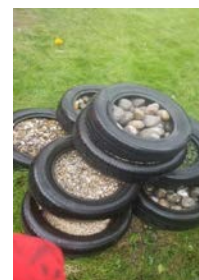


We welcome the entry into force of the Paris agreement that sets the long awaited regulatory framework to scale-up the implementation of these solutions and encourages further cooperation between private companies, policy makers and the financial community."

East Aggs Team Lend-A-Hand

With materials from the Quarry and Wharf the garden includes a rockery, herb garden, sand pit and slatted patio areas. This has provided the animals with an area where they can explore.

The sanctuary in Barrow Gurney opened its gates to unwanted, abandoned and often mistreated animals in March 1992. Since that time the charity has saved thousands of animals (see more at www.hollyhedge.org.uk).

CEMEX Rocks!



Rocks are a major constituent of many of the building materials produced by CEMEX. The location of suitable rocks in a form that can be exploited is down to geology.

The Extractive Industry Geology (EIG) conferences, held every two years, are a unique scientific and technical shop window for the non-petroleum extractive industry. They are an opportunity for earth



scientists associated with the extractive minerals sector to keep abreast of current and future trends, innovation and best practice.

The last such conference was held in September this year which marks the 50th anniversary of the Aberfan tip disaster in South Wales. The keynote lecture examined the factors leading up to this catastrophe and the implications for the UK extractive sector.

Other lectures covered health and safety, geotechnical, hydrogeological, mineral exploration and ecological aspects of the quarrying industry.

Together with their consultants Wardell Armstrong, CEMEX presented results of their 10 year programme of monitoring of springs in a nature reserve called Monk's Dale, located 2km to the south of Dove Holes Quarry. In order to operate effectively the Quarry needs to be dewatered with potential impacts on water features and groundwater dependent ecosystems. Monk's Dale Site of Special Scientific Interest (SSSI) is a spring-supported fen habitat of national and European importance.

The conclusion from the monitoring is that the fen habitat is dependent on groundwater flowing into the valley from a higher level associated with changes in geology and that it lies beyond the influence of operations at the Quarry.

James Reflects On 15 Years Of Law With CEMEX...

"It hardly seems possible that it is 15 years ago on 1st October 2001 that I joined RMC (UK) Limited as a 5 year qualified solicitor from a small private practice firm based near the British Museum in London. Thorpe provided a beautiful setting which made me feel I had landed the dream job with no commuting into town either!



In addition to dealing with sales of surplus non operational land and lease management work, I was taught all about mines and minerals and the specialist knowledge needed for mineral leases (which was completely new to me).
