Weekly Health And Safety Message From Michel



Congratulations to you all for a LTI and TRI-free week. This is our 10th consecutive week being TRI-free for employees which is very pleasing and rewarding for all of us. That said, please make sure you do not relax on any Health and Safety related matters: staying alert and focused is the only way forward to ensure all stakeholders are safe interacting with us, anywhere, anytime. As previously commented, this requires above all a permanent risk-free attitude - being 100% alert; step-in systematically even for apparent 'minor' issues as there is no such thing as 'minor' as far as safety is concerned; always plan-do-check-act and apply our policies and procedures scrupulously.

In my previous weekly message I highlighted the risks related to isolation procedures and urged everyone to read and act upon Andy's latest alert on this topic. Sadly, the tragic incident that occurred in the Czech Republic last week reminds us how important proper isolations are across our operations. Please check again your relevant local standards against Andy's safety alert.

Stay alert everyone, especially in the holiday season that is riskier in nature.

Safe Isolation – Safety Alert



Isolation of machinery before carrying out maintenance is one of the most fundamental health and safety rules. Recent fatal incidents in the industry, including one in our own operations, have illustrated the tragic consequences when isolation is not 100% effective.

This Safety Alert details some shortfalls in isolation arrangements identified by recent audits that are being

carried out across our operations. It is essential the current programme of audits is completed rigorously, by people with the necessary knowledge and experience.

Please review the Alert and ensure, where shortfalls in isolation arrangements are identified, immediate action is taken to guarantee the safety of all personnel; please note that where isolators are identified that can be locked in the "on" position it is policy that they must be replaced/rectified.

Please display the Alert (at the end of this document or in the download section on UK News website) on relevant notice boards.

Building A Better Future For The Swifts At Rugby



Nine metres above the ground, on the side of the one of the buildings at CEMEX's Rugby Cement Plant, Mick and Alex attached 12 new 'homes' for Swifts. Swifts are a quintessential sign of the British summer and although, towards the end of the season when Swifts visit this country, the new 'homes' may well attract some interest. Incorporated into the 'homes' is a 'caller', a pre-recorded sound of a Swift's call that plays at dusk and dawn to encourage new occupants to move in. "I'm sure our new homes will be perfect for these amazing birds and hopefully over the coming years, they will make our Plant their UK destination. Swifts will soon be on their

way back to Africa so our 'new build' is in preparation for next year. Next summer we look forward to seeing and hearing Swifts as they soar over Rugby rooftops on a summer's evening," comments Jamie Jordan, Environmental Manager, Rugby Cement Plant.

Swifts are the perfect house guest. They are only in the UK for three months of the year; make no mess when nesting and help get rid of flying insects and mosquitoes. Sadly, their numbers have been rapidly declining, due in part it is thought, to the lack of homes in our urban environments. CEMEX is working in partnership with the RSPB to increase the biodiversity of its 400+ sites. The introduction of the Swift boxes is one of the measures to help give nature a home. Rebecca Pitman, RSPB Swift Cities Project Officer, says: "The Swift is truly an urban bird and sadly they have declined by an alarming 47% between 1995–2014. They are now an amber-listed species on the list of Birds of Conservation Concern. When they arrive back in the UK from Africa they return to the exact same location year after year. Swifts like to nest in the rooftops of old buildings but developments and renovations often destroy suitable sites. The new CEMEX homes at the Cement Plant can offer this great bird a great home," Rebecca concludes.

Technical Development Programme Team Finish Readymix Rotation





UK SAFETY ALERT



SAFE ISOLATION - LOCK OUT, TAG OUT, TRY OUT

Details of Incident

Effective isolation of machinery before carrying out maintenance is one of the most fundamental health and safety rules. It should be expected that isolation arrangements are robust on every site; however it is a great concern to learn that recent isolation audits across our operations have identified shortfalls in our processes and procedures.

Key Findings

So far the audits have identified sites where:

- There is uncertainty regarding exactly what equipment switch gear isolates
- Switches can be mistakenly locked in the "on" position: we believe this was a factor in a recent industry fatality and, in some cases, may contravene the IET Wiring Regulations
- A lack of clarity with some switch gear whether it is "on" or "off"
- Defective isolator handles, allowing access to electrical panels using a panel key, while the isolators are "closed" or "open and locked out"

Key Review Points

It is essential that the ongoing programme of site isolation audits is completed rigorously by people with the necessary knowledge and experience. In particular LOTOTO procedures should ensure:

- Operation of switches, valves & machinery are clearly labelled
- All forms of energy are isolated
- Each person locks out with their own unique padlock(s)
- Equipment up & downstream is also isolated
- It is not possible to lock isolators in the "on" position
- Isoation is proved to be effective before work starts
- "Manager in Charge" locks are used where possible

Where shortfalls in isolation arrangements are identified, immediate action must be taken to ensure the safety of all personnel. Where isolators are identified that can be locked in the "on" position it is policy that they must be replaced / rectified
