#### Sergio Asks For A Safety Stand Down



Dear Colleagues,

I am reaching out to you in order to share a concern on the recent increase in the number of injuries across Europe in the last few weeks.

Unfortunately, after a promising start of the year, we have witnessed the number of injuries increase in our cement and materials business.

All these injuries could have been avoided, and it merits a pause and reflection about those affected, their families, and the risks to us and our colleagues.

We have made significant improvements in Health and Safety over the last few years, and many of our facilities operate now with Zero injuries regularly. But as the recent spike in incidents remind us, accidents and fatalities are only a risk condition, or a risk behaviour away.

Your leadership and commitment are key to prevent this from becoming a trend in Europe, and act immediately to review the way we are implementing our Health and Safety management system in all our operations, and share an increasing sense of urgency, particularly during the vacation period and unusual warm weather in some locations. Please do and ask all our colleagues to:

- ALWAYS follow the rules and procedures they are there to protect you!
- ALWAYS challenge unsafe behaviours and conditions don't walk past!
- ALWAYS report all near misses and hazards they are an early warning and could prevent injury!
- ALWAYS Stop and Think take a few minutes to plan the job before doing it!
- ALWAYS look after yourself and each other we are a team so let's keep each other safe!

I appreciate any comment or feedback that might help us improve the health and safety of our colleagues, contractors and general public. Please feel free to reply and I will review them personally with our Health and Safety team.


#### 21 Years LTI Free For Denge Quarry

#### Look After Your Skin



With the summer break upon us let's remember the 'H' in Health and Safety. With this in mind, let's think about how our environment affects our skin, particularly relevant as temperatures rise over the next couple of months.

The skin is the largest human organ and it plays a vital role as your body's first line of defence against physical, chemical and microbiological hazards.

It does several jobs for us, it:

- protects the inside of the body from damage
- helps to keep our body temperature more or less the same
- gets rid of some body waste products through sweat

#### SKIN PROBLEMS

There are two diseases of the skin which we can help eliminate or reduce the risk of:

- Skin Cancer
- Dermatitis

#### SKIN CANCER

- Sun provides warmth, energy and vitamin D, but repeated exposure to ultraviolet radiation in sunlight can cause brown spots, sun burn, wrinkles and potentially, skin cancer.
- Avoid tanning and UV tanning booths. According to the Skin Cancer Foundation, one indoor tanning session increases melanoma (severe skin cancer) risk by 20 percent





#### HELPING TO BUILD A GREATER BRITAIN

- Check your skin regularly. Pay attention to odd freckles, moles, and growths on your skin, and consult your doctor if you notice any changes for an early diagnosis of skin diseases and its treatment
- Protect your children from the sun. Keep babies younger than 6 months old completely covered and in the shade

Help your workers protect their skin by providing Sun Protect Stations.

#### DERMATITIS

Dermatitis is the second most commonly reported occupational disease. As with all occupational diseases prevention is the key, as with most cases of occupational dermatitis. Preventing skin contact with chemicals or other skin damaging agents will prevent the disease.

Preventing Dermatitis:

Control at the Source

- Product substitution
- Control along the Path

• Engineering controls: ventilation, isolation booths, etc Control at the Worker

- PPE gloves, safety glasses/goggles, overalls, boots
- Administrative controls: company policies and training
  - Personal hygiene

#### Time To Walk The Talk With Business Fights Poverty

#### Dove Holes Attempt To Cycle The Distance....



Last Wednesday 62 volunteers from the Dove Holes team attempted to cycle the distance from Land's End to John O'Groats in 24 hours on three exercise bikes (about 1,400 KMs). Roger Taylor, Operations Manager for DSM, remarked he could not believe the commitment and effort every one of the volunteers put in to complete this event.

The ages ranged from early 20s to early 60s, but everyone put in 110%. The idea was for every volunteer to complete as much distance as they could in 60 minutes and then swap over, obviously this quickly became a competition for some of the team,

some even completed two hours. D Heathcote covered the most distance in 60 minutes - 45.19kms and H Gill covered the most distance in two one hour stints - 83.76kms. J Berry managed an incredible 20.21kms using his hands and arms because he had recently had an operation on a delicate part of his body.

They had a couple of malfunctions along the way: a bike wouldn't record the distance being travelled but luckily the company they hired the bikes from were quick to respond and brought them a



replacement within three hours, and they also had a trouser malfunction but the less said about that the better!

The Dove Holes team didn't only manage to get from Land's End to John O'Groats, but they got over half way back again by completing an astonishing 2,296.62kms, that is an average of 35kms for each person. There is a great buzz going around the quarry about this accomplishment.

# Safety Stand Down

### What is a Safety Stand Down?

- It's a site meeting
- Lead by site managers
- Lasting about 30 minutes
- An opportunity to talk openly about safety issues with everyone available (employees and contractors)
- Active participation is essential
- Intended to raise safety awareness and increase the level of alert
- Often held out in the workplace

### Why we are calling for this Safety Stand Down in Europe?

- There has been an increasing number of serious incidents in recent weeks across Europe
- We need all teams to be aware of this concerning trend now, so we can take action quickly to prevent further injury and suffering

### **Topics for Discussion during the Safety Stand Down?**

- Please, follow this guide to prepare your Stand Down
- Refer to President of Europe, Sergio Menéndez, safety message
- Talk about the incidents in Europe that are included in this guide or, preferably select some that are particularly relevant to your site or business area...Select incidents you think are most applicable to your audience
- It is important to call for action from everybody. Ask people what they can do personally to improve safety for themselves and each other and get their commitment.

Employee LTI France Jan 2019



In the morning of the 3rd day of the operation, in order to replace the last 2 beaters, the team applies the operating mode: the rotor is released then starts to rotate very slowly and is going to stop.

For an unknown reason and contrary to the operating mode, an operator tries to slow down the rotor with a crowbar while it was still moving. The other members of the team had no time to react. The crowbar moves and hits the operator's jaw. Rescue teams are immediately called and the victim is evacuated to the hospital. After medical checks at the hospital, it appears that the employee suffers from a broken jaw and requires surgery.





Contractor Minor Injuries UK Mar 2019




A truckmixer, operated by an independent haulage contractor, rolled over on route to a customer site. The incident occurred as the vehicle entered a sweeping right hand bend and resulted in the vehicle turning onto it's nearside, coming to rest partially on the pavement and on the public highway. Thankfully, the driver escaped with nothing more than bruising and no other parties were involved, although a pedestrian was in close proximity. The truck, valued at over £100,000, was an insurance write off.





Contractor LTI Spain April 2019





CEMEX was acting as principal contractor on a Soil Stabilization contract and had sub contracted this work to a third party. The accident took place on a rural road, about 5 kms from the contract site, when the worker was checking the cement spreader equipment and trying to unblock the screw conveyor located at the rear. He was pulling a homemade wrench towards him, which slipped off and hit his face, causing a cut to his face. Both vehicle and screw were switched off.

The worker was transferred to the hospital and received stitches to his cheek. To avoid infections the worker had 8 days off work and is now back working.





Contractor LTI Germany May 2019





The injured person is an employee of a subcontractor for scaffolding works. Together with two more colleagues, he was dismantling a scaffolding at a clinker cooler building; there were no lateral guard rails and toe boards at the time of the incident.

When passing pieces of the scaffolding vertically downwards between them, a plank slipped out of the injured person's hand. As he tried to re-grab the falling plank, he lost his balance and fell from a height of approximately 3 metres onto the ground. He suffered a concussion and some bruises on his upper body.





# **Key Discussion Points:**

- Do the incidents involve unsafe behaviors, unsafe conditions, or both?
- Do you think the people involved followed the right procedures?
- Do you think they took the time to Stop, Think and Act?
- Would a simple risk assessment have help to avoid these incidents?
- Were all the Safety Essentials followed?





### **Guide questions during discussion**

- What are the most common unsafe acts we are seeing in our operations?
- Which of our Safety Essentials are more relevant to avoid the incidents?
- Are we all leading by example, showing Safety is our first priority?
- Are we Looking after ourselves and Each Other? When was last time you did it?
- Are we Stopping and Thinking before Acting? Are we using Take 5 / Worksafe properly?
- What more can we do as a team to prevent further incidents? Any suggestions?
