#### **Safety Update**



While last week was Lost Time Injury (LTI) and Recordable Injury (TRI) free across Europe Related Businesses, unfortunately the team has had to retrospectively add an employee TRI to the report, following a Restricted Work Injury at the UK Floors factory in Wick at the end of the previous week.

The injured employee strained his ankle on the Friday morning, when he lost his footing while climbing down from a static platform following some maintenance work. He was able to resume work after visiting a medical centre on the Friday and it was initially thought he had suffered a first aid injury, however, on return to work after the

weekend, it was apparent that he could not do his full range of duties and was placed on restricted work. The platform is just over 1.6 metres from the ground, with a short vertical access ladder.

The requirement to "Get a Grip" and maintain three points of contact on steps and stairways, and when getting in and out of vehicles is one of the fundamental behaviours included in our Safety Essentials. Everyone must follow the Safety Essentials if they are to keep themselves and their colleagues safe. In addition, we have a moral duty to look after each other and Step In if we see anyone acting unsafely.

Finally, it is important that we retain our additional focus on contractor safety throughout the remainder of this quarter of the year, a period when we have seen contractors are at greatest risk of serious injury. Managers and Supervisors carrying out site VFL tours are asked to ensure they involve as many contractors as possible in their observations and discussions, with a target of between 50% and 75% of VFLs involving contractors.

#### Safety Alert



A serious injury was suffered by a colleague in Europe Central Materials when he became trapped in a conveyor, and a Safety Alert is now available at the end of this document and in the download section of the UK News website, which details the circumstances. This incident reminds us of the importance of ensuring safe systems of work for the isolation of machinery are clear and understood by all who are required to work on equipment, with prominent, well equipped lock out stations that reinforce the importance of this life saving requirement.

Teams are encouraged to discuss the Alert to help maintain everyone's awareness of the need to ensure we Lock Out, Tag Out and Try Out (LOTOTO), before removing safeguards and starting to work on any equipment.

#### **LTI Milestone For UK Admixtures**



The Admixtures team in the UK reached 18 years LTI and TRI free last weekend (last LTI/TRI 01.09.01). This is an excellent achievement, thanks and congratulations go to the team on this sustained injury free performance.

This reminds us all that there is no reason anyone should suffer an injury at work and we must all continuously strive for Zero4Life performance across all our operations.

#### LTI Free Week



Well done to Europe Cement Operations which saw no incidents last week. This was the third week in a row with Zero LTI and TRI for contractors and employees.

Europe Supply Chain and Europe West Materials also reported no LTIs or TRIs last week

#### **Dove Holes Quarry Lend-A-Hand At Historic Local Canal Basin**



In August six of Dove Holes' finest night shift workers completed a lend-a-hand at Bugsworth Canal Basin, which is about four miles from the quarry.

Ian Edgar from the Bugsworth Basin Heritage Trust had approached the quarry for help with repairing a steel fence which had become dangerous and unsightly. The Trust could get the materials but didn't have the tools, manpower or experience to complete the task.

"The history between the quarry and the canal basin meant it was something we really wanted to do" said spokesperson, Mike Hancock.

The canal basin at Bugsworth was opened in 1796 and became one of the largest inland ports on the English narrow canal network. Opened as a means of transport to get limestone into Cheshire where the chemical trade was developing at that time, it remains unique as the only complete example of a canal tramway terminus in Britain. The tramway was built between the canal basin and Dove Holes to transport the limestone from the quarry onto the barges.

The CEMEX employees can be seen next to a replica truck (used to carry limestone) at the picturesque Bugsworth Canal Basin.

Patrick Worwood (Night Shift Fitter Chargehand) who led the team, was delighted at the finished results and so were the members of the Trust who were present. Patrick commented: "Everything went like clockwork as we knew heavy rain fall was due about 2pm. It was a strange day as it was the day the dam at Toddbrook (Whaley Bridge) breached and we could see a helicopter about quarter of a mile away surveying the damage. We were getting reports about the dam and road closures and wondering how we would all get home. Fortunately, we managed to replace all the rusted posts and give them a paint before the heavens opened.

Gary Bresnahan, painter for the day, commented: "It's really transformed the appearance of such a historic local and tourist attraction and it's nice to give something back."

As with previous visits to the Doctor's home planet of Gallifrey, they requested to film in Taffs Well as they like the backdrop of the multi coloured rock faces.



## Employee was pulled into running machinery – LTI

SAFETY ALERT

#### **INCIDENT DETAILS**

On 5/8/2019 the employee worked alone in a secluded work site, heard a whistling sound. Firstly, he switched off the machine and carried out LOTOTO. He didn't identify the source of sound. Then he turned the machine on. Subsequently, he removed guarding of the conveyor belt under the hopper during operation and tried to identify the source of sound. He touched the roller by hand with the intention of stopping it to find the defective roller and the first roller pulled him into the machine with his glove. The employee suffered a fractured forearm, lacerations on the wrist and burns to the forearm and broken ribs. The employee is on sick leave after the operation.

#### **KEY FINDINGS**

- The employee had the necessary qualifications to work.
- He had enough time to rest between shifts.
- The employee was trained in health and safety (H&S) and was familiar with the operating documentation.
- The employee breached the Safety Essentials during operation, by removing guarding and touching the device.
- The employee violated the instructions for operating and maintaining the equipment.
- The employee did not contact the more experienced colleague and tried to fix the problem himself.

#### WHAT CAN WE IMPROVE?

- Examine the technical solution of guarding the net covers should be replaced by full metal covers
- Develop safe procedures for carrying out inspection of belt conveyors
- Non-standard activities should be performed in more than one person

#### **KEY POINTS TO CHECK**

- Verify that employees know LOTOTO procedures
- Check that employees know TAKE5 procedures
- Check whether the lone work procedures are followed – use of radio equipment, regular reporting.
