Safety Above All Else.....



July was a difficult month for us in terms of health and safety in the UK, with three Lost Time Injuries in quick succession; these incidents are detailed in the Alerts at the end of this document or in the download section of the UK News website.

Two of the incidents resulted from slips, trips and falls, which is our most common cause of injury. Across Europe 36% (17 out of 47 TRIs) of our most serious injuries this year have resulted from slips, trips and falls, while in the UK this is even higher, at 42% (5 out of 12 TRIs). As sites and as individuals we can minimise the risk of injuries:

SITES	PERSONALLY
Maintain good housekeeping	Keep work areas tidy
Demarcate dedicated walkways	Wear suitable footwear
Provide suitable lighting	Keep to designated pedestrian routes and crossing points
Identify and rectify slip/trip hazards where possible	Always maintain 3 points of contact on steps, stairways and ladders"Get a Grip"
Highlight remaining slip/trip hazards with yellow paint	Walk, don't run
Display "Get a Grip" signs in prominent locations and, during inductions, remind people of the importance of maintaining 3 points of contact on steps, stairways and ladders	Look where you are placing your feet, particularly when stepping down from ladders, vehicles and mobile equipment
Ensure steps and stairways comply with relevant standards	Take action, where you can, to remedy any slip/ trip/fall hazards, and report all Near Misses/ Hazards
Prepare sites ahead of winter, ensuring frost warning signs and arrangements for clearing walkways are in place	

The third Alert refers to our Marine Operations, it also contains lessons for us all, in terms of ensuring specific safe systems of work are in place and included in inductions where required, the importance of



good and timely communication, and the need to review tools and equipment to reduce risk as far as is reasonably practicable.

Please review the Alerts with your teams as appropriate. In particular, as we approach the autumn, a review of the arrangements in place to minimise the risk of slips, trips and falls would be timely.

Alerts should also be displayed on relevant noticeboards.

Two LTIs Last Week - One In Rugby....



Unfortunately, two lost time injuries have been added this week, one retrospectively as a result of an employee suffering a slip/trip/fall incident on a quarry in Germany.

The second incident was at the cement plant in Rugby where a contractor fractured a bone in his knee when a bulk bag fell on his leg. The contractor had stacked one bag on top of another, using a fork lift truck, however, in doing so he created a small tear in the bottom bag. The content of the bag

began to spill out and the contractor attempted a repair with Denso Tape. Unfortunately, the stack became unstable and the upper bag fell on the contractor.

Details of the incident will be shared in a Safety Alert, once the investigation is completed, however, in the meantime, it's a clear reminder for us all to keep out of the "Line of Fire" and to STOP & THINK before starting a task.

Contractor Safety – AVETTA System



The increase in contractor LTIs this year across Europe is cause for concern and, as highlighted previously, we need to sustain the extra focus on contractor safety throughout the rest of this month. We need to ensure we effectively plan any contract works, only use approved contractors who have received an appropriate induction and Permit to Work, and who are monitored through close and effective supervision while working for us.

Thanks go to Stuart Glover from Cement Operations for taking the time to record the advantages of the AVETTA contractor verification system and, in

particular, their EmployeeGUARD functionality, which is used to track the competency of individual contract personnel.

Geotechnical Awareness – recognising a change on the face since yesterday could be a lifesaver and stockpile slips can engulf a loader if not worked correctly.

Workplace RCS – updates on workplace legislation and developments in personal protection and monitoring.

Lifechanging Events – a death or serious injury to a colleague can have a profound and far reaching personal impact on us all, not to be underestimated.

UK SAFETY ALERT

CUSTOMER SITE – TRIP RESULTING IN DRIVER INJURY

DETAILS OF THE INCIDENT

A hired truckmixer and Driver was delivering to a customer on our behalf. Following discharge of the 6th load of a concrete pour, the Driver was washing off the truckmixer chute in the customer's designated area. The Driver was returning to his cab, when his foot became tangled with a strapping band from a pallet. He fell, landing on a pile of rebar, injuring his knee and ribs. Whilst he continued working, delivering another load, he was unable to complete his shift or work the following days.



KEY FINDINGS

The area for washing out was also used as an area for materials storage. Prior to the incident, others may have observed that housekeeping could have been improved. The Driver was not local and had taken time to negotiate directions, prior to arriving at site. There may have been some perceived haste.

There was a delay in reporting the incident via the correct reporting route.

HOW COULD THIS HAVE BEEN AVOIDED?

- Ensure Drivers are trained in MYSPACE, checking for hazards on site.
- Report Near Misses / Hazards, whether on customer or CEMEX sites.
- Ensure good housekeeping.

KEY REVIEW POINTS

- Ensure all Drivers, including hired personnel are inducted and aware of the MYSPACE principles
- Encourage reporting of Near Misses / Hazards
- Maintain good levels of housekeeping
- Always report any accidents or incidents immediately via CEMEX line management

POSITIVE POINTS

- Driver induction was carried out
- MPQC Driver Skills card was checked
- The haulage company is FORS accredited
- The Driver was compliant with PPE requirements



LTI - EMPLOYEE INJURED AFTER TRIPPING ON STEP

UK SAFETY ALERT

DETAILS OF THE INCIDENT:

A mechanical fitter had been working with a colleague on a task in the kiln building and after completion was travelling to the next job. As he walked along the same route he had travelled several times in the morning, he passed too close to a concrete plinth outside a switch room and he stumbled on the step, falling on to his knee. He continued working for the rest of the day but the pain continued to worsen overnight and he was later diagnosed with possible ligament damage.

KEY FINDINGS:

- The fitter was familiar with the route and was not intending to walk over the step.
- The layout allowed a direct approach to the step, giving him clear visibility of the obstruction.
- Lighting levels were low, and the step was partially in shadow.
- The step was highlighted with paint but this was worn and covered in dust.
- The IP has a history of musculoskeletal problems.

HOW COULD THIS HAVE BEEN AVOIDED?

- Improved lighting.
- Maintaining hazard identification controls.
- Good housekeeping keeping floors dust free.
- Consider where we are placing our feet.



KEY REVIEW POINTS:

- Are walkways, especially hazard areas, appropriately illuminated
- Are hazard controls such as highlight paint maintained and kept dust and spillage free?
- Where hazard controls are not effective do we warn others by using the Near miss/ Hazard alert system?
- Do we consider routes to and from the workplace and personal capabilities when carrying out Worksafe/ point of work assessments?
- Do we all look where we are placing our feet?
- Do you Get a Grip and always maintain 3 points of contact on steps and stairways?



SAFETY ALERT

SEAMAN STRUCK BY MOORING LINE

DETAILS OF THE INCIDENT

A Marine Dredger was coming into position in a Lock, when the order to secure one of the mooring lines was given. The Seaman secured the line on the mooring bitts (ship's bollard) as instructed; however the vessel continued to move ahead slightly; placing strain on the secured mooring line. The line surged (slipped) on the mooring bitts; the standing (unloaded) part of the line whipped from the deck, striking the Seaman in the groin. The Seaman was evacuated to hospital by emergency ambulance and underwent exploratory / corrective surgery.

KEY FINDINGS

- The mooring rope size in use is essential to ensure vessel safety; however, the vessel mooring equipment is undersized by contemporary standards.
- The layout of mooring equipment prevents the use of best operational practice.
- There was no specific mooring plan in place for the task.
- The induction procedures were followed; however, they could be more focussed on ship specific issues.
- Co-ordination of communications and actions of the Bridge Team and timing of instructions given to Deck Crew could be improved.

KEY REVIEW POINTS

- Task specific mooring plans should be available where required
- Review co-ordination between the timing of instructions given to deck crew and actions executed to control and manage the vessel; to ensure Deck Crew are not subjected to risk during mooring operations.
- Review mooring equipment onboard vessels to identify potentially deficient mooring equipment design conditions and any improvement opportunities
- Guidance in assessing the experience of Deck Crew members should be developed
- Induction in mooring operations for new crew members should include ship specific issues
- Periodic induction refresher training should be considered for long term crew members
