#### **COVID-19 Global Safety Alert**



Sadly, we are aware of nine deaths related to COVID-19 involving colleagues overseas, including both employees and contractors. While infection rates in the UK are reducing, this is a sombre reminder of the risks we continue to face from COVID and the need to follow guidance from the Authorities and Industry Organisations, while also complying with the CEMEX COVID Protocols and local Good Practices.

Global Safety Alerts have been made available relating to two of the fatalities within the business. Please discuss them with your team, highlighting the importance of following the 4 Key Safety Behaviours that Save Lives and ask them to discuss these incidents with colleagues and family members, encouraging them to ensure they are looking after themselves and each other.

Managers and Supervisors are required to review the Alerts to identify any gaps in local control measures, taking remedial action as necessary, and also display the Alerts on noticeboards.

CEMEX Global Protocols require all Fatal Alerts to be communicated and Managers to capture the signature of employees and contractors to confirm they have received and understood the information and the control measures they need to adopt. In addition, operations are invited to observe a one minute silence in memory of the deceased at the time of discussing a Fatal Incident Safety Alert.

#### **Dove Holes Night Shift Team Calm Under Pressure**



Well done to the Night Shift team at Dove Holes, whose ability to stay calm under pressure recently had a life-saving result.

Mark Lawton, Tony Limer, Nathan Shipstone and Gary Bresnahan reacted to an emergency situation where a security guard was having a heart attack.

The Operatives showed teamwork and a collective calmness in reassuring, comforting and treating the poorly person. Mark (lead

hand and first aider) took control of the situation instigating the site emergency procedures to ensure that medical help was summoned and that Tony was present to meet the ambulance. The security guard was treated as a responsive casualty with chest pains and was monitored using first aid knowledge and the onsite defibrillator which had been attached. Luckily for the casualty the CEMEX Operatives had reacted quickly and safely with real purpose and endeavour which meant he was able to get to hospital alive where he was to have two stents fitted.

Liam Perkins, Night Shift Manager, said: "The whole situation, while very challenging and frightening at the time, has given the site a 'boost'. Ian's wife and family have expressed how they will always be indebted to CEMEX and the lads that helped Ian. High Peak security have also expressed their gratitude. Having effective and robust systems with competent personnel can have literally life changing effects and must relay to CEMEX that putting these systems and people in place is very much worth it."

#### **CEMEX Launches New Mortar Paving System**



CEMEX is proud to present STREETPAVE, a complete three-stage bedding, bonding and jointing mortar paving system. The range consists of BS 7533 compliant products for rigid pavement construction.

All three products in the system are high performance and offer rapid strength, including; STREETPAVE PaveBase bedding mortar; PaveGrip priming slurry; and PaveFill flowing joining mortar. These products can be used together for pavements constructed with clay, natural stone or concrete pavers.

STREETPAVE PaveBase bedding mortar is made from Cement and graded Aggregates, and is available in a silo, bulk and 25kg bags. Once applied it is highly durable, suitable for walking on in 12 hours and driving on in 24 hours and can be laid from 10-75mm in one pass. It is perfect for paved areas of mixed foot and vehicular traffic alongside general private and public hardscape areas.

Meanwhile, STREETPAVE PaveGrip priming slurry uses specially selected Aggregates to create the essential bond between the bedding and the paving element. Delivered in bulk or 25kg bag, it is applied with a brush at 1-2mm thick and is suitable for high-trafficked pavement.

STREETPAVE PaveFill flowing joining mortar is the final step in this premium quality system. It is fastsetting and frost resistant with a 40MPa compressive strength and low shrinkage. Simple to mix and apply, PaveFill can be applied in joint widths of 5-50mm and up to 200mm deep in a single pass.

#### **CEMEX Moving Forward on its Ambition to Deliver Net-Zero CO2 Concrete**



CEMEX has announced its participation in the FastCarb Project, administrated by IREX, which aims to capture CO2 in Concrete, which is then used as Aggregates. The approach seeks to improve the quality of this type of recycled Aggregate by plugging the porosity and ultimately reducing the impact of CO2 in Concrete contained in structures.

CEMEX is involved in this working group focused on the transition to Concrete as well as applications to prefabricated parts and structures, and in understanding the accelerated carbonation mechanism for recycled Concrete Aggregates.

The FastCarb Project started in 2016 with a multidisciplinary group of partners, such as public organisations, private research centres, contractors, engineering companies, laboratories, and different industries, including CEMEX. The project works to design and implement an accelerated carbonation process at pre-industrial scale to store CO2 in the Aggregates of recycled Concrete, and to characterise the environmental and economic viability of the process industrial recycling envisaged.

After completing the first phase of the experimental approach at the laboratory level with promising preliminary results, the project is now entering the second phase seeking to tackle the industrial approach. In this industrial approach phase, CEMEX was recently assigned to evaluate the physical and mechanical properties of the carbonated recycled Concrete Aggregates when used in ready-mix Concrete in the laboratory facilities at the National Technical Centre CEMEX France.

"This initiative is a relevant component of our ambition to deliver net-zero CO2 Concrete globally to all of our customers by 2050," said Vicente Saiso, CEMEX's Director of Sustainability. "FastCarb aims to allow us to develop the circular economy of Concrete by improving the quality of recycled Concrete Aggregates."

#### Reminder of Business Policy on Travel



As lockdown measures ease, we understand the reasons for business-related travel may increase, however, we would like to remind all employees that travel should only take place if absolutely essential and should not be routine.

Please see below for the latest guidelines for travelling as part of your role at CEMEX:

- International air travel to / from Europe: Restricted, requires EVP written approval and informing Global Security.
- International travel within Europe: Restricted, essential business travel only, requires local RRT written approval (both countries, if visiting CEMEX locations) and informing local Security.
- Domestic (overnight) travel: Only if essential and a clear business need. Requires Line Manager approval and informing local Security.
- Domestic same-day travel: Requires Line Manager approval.

If your journey involves international travel within Europe or domestic overnight travel, please fill in the form here to give notice to local Security.

It is very important that we all follow these guidelines and keep the relevant Senior Manager(s) informed about any travel we take. This ensures that we can provide a record as required for the Track and Trace system should there be an outbreak in an area our employees have visited, or if our employees travel to any hotspots.

# **GLOBAL COVID-19 ALERT**

## **INCIDENT DETAILS**

A plant mechanic, who lived in the same accommodation as some of his colleagues, was absent from work with asthma issues. The condition of our employee didn't improve after two days, so he was taken to hospital where he was provided with some medication. A day later his condition became worse as he began to develop breathing difficulties. He was taken to a local health center and was then transferred to a hospital for further treatment. After receiving an X-ray and some nebulization, he was discharged and told to quarantine at home. 2 days later, his condition deteriorated and although an ambulance was called, sadly, he passed away before being taken to the hospital.

## **KEY FINDINGS**

- Factors were identified in the spread of the virus, including room density, shared facilities and hygiene practices
- At the time of the incident, the protocols were yet not embedded in employee behaviour; employees seemed overconfident and underestimated the risk of COVID
- A lack of available rooms at the time of the incident meant that sole isolation was not possible for the employee
- The employee was unable to get properly diagnosed until after he passed away

## **MANAGERS – KEY POINTS TO CHECK**

- Our Key Behaviours that Save Lives are effectively communicated and regularly promoted to all employees and contractors.
- The Hygiene and Safety Protocols are fully implemented in all areas
- When accommodation is arranged for workers, checks are made to make sure the same Protocols and Behaviours are implemented and followed.
- All personnel are aware of the need to report COVID-19 related symptoms or if they have been in contact with a positive/suspicious case.
- Effective quarantine measures are in place and suitable checks are made
- COVID-19 Coordinator at the site is carrying out regular inspections to help ensure control measures are in place and being followed by all personnel.
- The availability of effective medical attention is proactively identified in case such support is needed.

## **ALL PERSONNEL - ACTIONS TO TAKE**

- Never be complacent and don't wait for contagion to strike before you start to take the necessary controls seriously!
- Always inform your supervisor if you develop COVID-19 related symptoms or if you have been in contact with a confirmed/suspected case and place yourself into immediate quarantine.
- Always follow physical distancing requirements, especially when in quarantine.
- Always follow our 4 Key Behaviours that Save Lives! They apply at work, at home, when commuting and everywhere!

# **GLOBAL COVID-19 ALERT**

## **INCIDENT DETAILS**

A contractor at a Logistics distribution center informed his line manager that he had a cough and sore throat and proceeded to get checked at the local hospital where they said he had a respiratory infection. Five days later, he noticed he had a fever and some difficulty breathing, so he decided to go to another hospital where he had a test and was advised to quarantine at home. The result was positive for COVID-19 and he was asked to return to hospital for treatment. Over the next 2 days his condition became worse and he needed oxygen to help him breath. After another two days he was moved to an Intensive care unit, where sadly, he passed away.

# Avoid exchanging items e.g. documents, pens, etc if you can

## **KEY FINDINGS**

Although it wasn't possible to confirm where the contractor caught the virus, the investigation team identified the following opportunities to further strengthen controls:

- Drivers were exchanging documents and other items with each other
- Some additional sanitization opportunities were identified e.g chairs, door handles, etc.
- While the contractor had received training about the necessary controls, the relevant Playbook training had not taken place (although it was scheduled)
- The Contractor reported his symptoms to his line manager and followed the local recommendations, In the early stages of his treatment, the contractor was transferred between 3 hospitals and the level of attention to his condition was described as varied

## **MANAGERS – KEY POINTS TO CHECK**

- Our Key Behaviours that Save Lives are communicated and regularly reinforced with all employees and contractors
- The Hygiene & Safety Protocols are implemented in operational sites/areas
- People are aware of the need to report COVID-19 related symptoms or when they have been in contact with someone else that has or is suspected to have the virus.
- Quarantine controls are implemented immediately when someone reports symptoms or contact with other suspected cases.
- Contact tracing is implemented to identify who else needs to be in quarantine.
- Measures are in place to eliminate or reduce the exchange of items between people
- The COVID-19 Coordinator for the site is carrying out regular inspections to ensure control measures are in place and followed by all personnel.
- Thorough cleaning and sanitizing regimes are in place, especially for items and in areas of frequent use

## **ALL PERSONNEL – ACTIONS TO TAKE**


- Always place yourself in quarantine immediately and inform your supervisor if you develop COVID-19 related symptoms or if you have been in contact with another person who has symptoms or has been confirmed to have the virus.
- Avoid exchanging and sharing the same items. If it's unavoidable for some reason, always follow the cleaning and personal hygiene measures that are in place and when necessary, wear gloves as well.
- Always follow our 4 Key Behaviours that Save Lives! Follow them at work, at home and everywhere. Encourage your family members to do the same to keep them safe as well!
