Back to Office Update



On Monday, some members of the 4th floor team at Rugby returned to the office for the start of an initial two-week trial. This will give us the opportunity to test if temporary office capacity levels are practical and highlight any pressure points / potential issues to be overcome.

The trial has been positive so far and feedback is being gathered throughout, some of which we have shared with you below:

"It's been great to see people back in

the office, its obvious work has been done to reduce surface areas so that cleanliness can be kept to an optimum but there is only a small number of people in at the moment – there may be more issues with more people around."

"I'm happy with the procedures in place at the office to accommodate everyone's health. There's pros and cons to working in both scenarios really as I can work well in both."

We have also spoken to some members of the Dispatch and Shipping Team at Wick who provided the below feedback about working on site:



"My initial concerns and vexations about returning to the workplace have been greatly assuaged by the satisfactory implementation of CEMEX's safer working practices. In fact, I am now of the mind that during these uncertain times a secure and stable workplace is somewhat of a blessing. The ability to work in an environment that promotes teamwork at a safe and respectful distance is advantageous to both productivity and personal wellbeing."

"CEMEX has certainly taken the proper procedures to make the office safe for everyone. Having helped to put the new safety measures in place, I knew I could feel safe returning back to the office."



Every week the RRT is monitoring the UK COVID situation and considering when a return to office may be feasible. Currently we continue to follow UK Government advice and work remotely wherever possible, and we will keep everyone updated on this situation.

In the meantime, work to prepare our UK offices continues:

- Screens are now in place on all floors of the Rugby office, and in the reception area
- Hand sanitiser dispensers for Rugby have arrived
- Screens for desks at Preston Brook will be installed next week
- A review of requirements has been completed at Peterlee



As previously communicated, we ask that employees continue to work remotely until advised otherwise by the RRT

As we see an increase in infection rates in certain areas of the UK, and indeed across Europe, it is more important than ever that we all understand the importance of adhering to these requirements and do what we can to prevent a potential spread of the virus.

Watch Your Hands



There was Safety Alert issued recently giving details of an incident where a driver's finger got trapped in a cab door. Please read the Alert, found at the end of this document or can be downloaded here:

Here are the details of the incident:

A contractor, who was operating an Articulated Dump Truck (ADT), stopped the vehicle in heavy rain to pick up a pedestrian and transport him to his light

vehicle at the base of the quarry. While sitting down in the passenger seat, the passenger closed the door of the ADT, however, the Operator's left hand was on the door frame to assist with leverage (to then reach across with his right hand to pull the door from the seated position). The passenger closed the door, trapping the Operator's hand between door and frame, causing laceration to the Operator's index finger. The Operator attended hospital where his fingernail was removed, and stitches applied.

COVID-19 Alerts



Importance of Following Government Guidance on Quarantine



As the Government announces further alterations to the list of countries with which the UK has travel corridors, we must all be alert to the changing nature of travel abroad and the impact this can have on our working and personal lives.

From 4.00am, Saturday 22nd August, all arrivals from Croatia, Austria and Trinidad & Tobago must self-isolate for two weeks.

This decision has been made because data from the Joint Biosecurity Centre and Public Health England has indicated a significant change in both the level and pace of confirmed cases

of coronavirus (COVID-19) in all three destinations. Also, from this date, Portugal will be added to the list of countries with which we have a travel corridor and quarantine will no longer be required.

If you return from a country that is not on the exemption list, it is a legal requirement that you self-isolate for two weeks and provide your contact details, in line with the advice <u>here</u>. **This means that you must not leave your home for any reason** – including to go to work, to exercise, for shopping or visiting friends and family.

As we have advised in previous communications, if you have any travel plans or a holiday you have booked to an area that may be subject to quarantine restrictions, please ensure you speak with your Line Manager who will seek guidance from HR. As a reminder for Managers, if a member of your team is away from the workplace because they are self-isolating, you must update the Health & Safety tracker by filling in the form here: https://forms.gle/WKDAFDdX81nRPTdz9

CEMEX expects all employees to look after themselves and each other and follow the Government guidance around self-isolation when returning from overseas. Please be aware that failure to do this puts our colleagues, families and the wider community at risk and may result in disciplinary action.



Leamouth Wharf's Best Op Ex Idea



Another big 'Thank You' goes out to all of our teams for continuing to develop and implement their ideas that will help make CEMEX a Safer place to work, with better quality and greater efficiency / effectiveness.

The ideas for this month's competition include:

- Leamouth Wharf: Used an old peristaltic pump along with some new pipework to pump approximately 50% of the silt that would previously been loaded onto a barge and disposed of at sea back onto the sand on the dewatering screen.
- Hatfield quarry: Replaced a rented tractor and bowser with a towable dust suppression unit
 which is usable with site trucks. This alternative is a more cost-effective solution to dust
 suppression.
- Willington quarry: Improved access to the Skako feeders by reusing some site redundant equipment and minimise work at height issues from this maintenance task.
- Halkyn quarry: Improved access to the large Don Valley triple deck screen to minimise STF and fall from height hazards by installing a stairway and handrails.

CEMEX Helps Local Food Project



CEMEX has recently donated money towards the innovative Rugby based 'Carryit Come' project. The charity aims to support the vulnerable elderly black community local to Rugby with culturally tailored food deliveries and meals.

Many of the government backed schemes supply foods which many of the black community are intolerant too and cannot eat – such as dairy based products and pasta. In addition, many of the food support schemes come from the main supermarkets which don't

supply the foods that this community typically eat (photo was taken pre-COVID).

The 'Carryit Come' initiative is a fantastic partnership between Negrills restaurant (Rugby) and NU:GEN charity and it delivers cultural groceries and cultural home cooked meals to the most vulnerable elders in the black community.

Sherril Donaldson, Managing Director, thanked CEMEX saying that our donation will allow them to continue this service for the next three months and provide approximately 500 meals.

"I would like thank CEMEX for their generous contribution to the Carryit Come Project. The funds will allow us to continue with a service that keeps the most vulnerable members of the community away from the environments where they are more at risk of contracting the virus. Willow Tit at Willington – More of a 'Status Quo' Kind of Bird!



RSPB visited CEMEX Willington quarry early March 2020 as part of a wider Willow Tit survey. The adjacent Derbyshire Wildlife Trust site is known to have Willow Tits breeding on site and CEMEX Willington quarry has some great habitat that will also sustain these now rare birds.

The Willow Tit is a back from the brink bird that is over 94% in decline: https://naturebftb.co.uk/the-projects/willow-tit/)

In late July RSPB visited the quarry again to the to discuss with Site Manager, William Newton, the presence of Willow Tit on site, to see how the quarry can help these birds. The planned restoration of

Willington will produce a great wetland site with ponds, fen and wet grassland along with the vital wet woodland that Willow tit depend on, complimenting the wildlife site next-door.



Some of the restorations are looking really good and well established. There are a number of mature willow trees on site and areas of thicket-impenetrable bramble amongst damp vegetation that is perfect feeding for Willow Tit. The standing dead wood and broken tree limbs need to be kept too, wherever it is safe to do so, as this is future Willow Tit nesting habitat.

Willow Tits excavate their nest sites from wood, in a similar way to Woodpeckers, although Willow Tits need rotting softer wood to use a rock music analogy, you could say Woodpeckers are 'Metallica', death metal fans – the robust head bangers of the bird world –

whereas Willow Tit are more of a 'Status Quo' - soft rock kind of bird!

Site Manager, Bill, will be undertaking some active management for Willow Tit, retaining dead wood and using some felled timber pined to trees, like nest boxes to ensure there's plenty of opportunities for nesting and retaining those brambly areas for feeding.

We are really pleased that CEMEX are working with RSPB and 'Back from the Brink' on Willow Tit at Willington, it will be the first CEMEX site to trial a joint RSPB/Willow Tit project.

GLOBAL COVID-19 ALERT

INCIDENT DETAILS

A contractor, who worked in a concrete pumping operation, heard that a family member from another household had passed away with the COVID-19 virus, so he visited the house to directly support family members. Afterwards, he also attended the funeral service with the rest of the family. When the contractor returned to work, he didn't report the event to his supervisor, and he continued working for 4 days without displaying any symptoms himself. On the 5th day however, he began to feel weak and he asked his supervisor for permission to go home. After feeling no better the following day he visited several Doctors, because he was not confident about their conclusions or the medication being provided, and he suspected something more serious. By the following day, he had a high fever and was now experiencing breathing difficulties and two days later he was admitted to hospital. Sadly, the day after, our contractor passed away. The contractor's wife also caught the virus, but has since made a full recovery.





KEY FINDINGS

- The contractor had direct contact with his deceased family member and other members of that person's family
- The contractor did not declare his contact with an infected person and other potentially infected people.
- The screening procedures at the site where he worked did not include a specific question at that time about declaring any contact with others that have or are suspected to have the virus.
- Improvement opportunities were identified to better influence the adoption of key

GLOBAL COVID-19 ALERT

C-19A 2020 / 2 Inform

INCIDENT DETAILS

A company readymix truck driver decided to visit his mother in her home to support her, because she was ill with a high temperature and an upset stomach. Our employee spent around 1.5 hours with her before returning to his home and then to his place of work the next day. Four days later, he heard that his mother's condition had become worse and that she had been admitted to hospital with respiratory failure and other COVID-19 symptoms. Our employee was placed in guarantine and subsequently tested Positive for the virus. His health condition deteriorated in the following days and he was admitted to hospital, where sadly, he passed away just over a week later

KEY FINDINGS

- · Our employee visited his mother who was ill with COVID-19 symptoms
- Despite being quarantined, he decided to visit his mother again when she was first admitted to hospital.
- It's thought he was most likely infected when he visited his mother for the first time. He returned to work and only notified his supervisor days later when his mother was taken to hospital.
- · While he was in hospital, his wife began to display symptoms and received treatment for the virus. His mother is continuing her recovery; however another close relative has since died with COVID-19 related symptoms as
- Our employee was also in contact with 3 other drivers while at work and one of them was subsequently found to have caught the virus as well.

MANAGERS - KEY POINTS TO CHECK

- Our Behaviors that Save Lives campaign has been communicated to all employees and contractors with regular promotion of the requirements, including the need to Identify symptoms and inform, which includes when in contact with a suspected/confirmed case.
- All the company protocols are implemented in all operations
- The control measures are effective, and any needed improvements are timely implemented.
- All site Managers and the COVID Pandemic Coordinator have been trained in our HSMS Element 15 requirements.

ALL PERSONNEL - ACTIONS TO TAKE

- Inform your supervisor immediately if you have developed any COVID-19 related symptoms or if you've been in contact with a confirmed/suspected
- Always follow the government guidelines and company requirements to keep yourself and others safe.
- If family members or close friends are ill, do not visit them.
- Always follow our 4 Key Behaviors that Save Lives, including when at work, when commuting and when at home!




SAFETY ALERT

MOBILE PLANT OPERATOR TRAPS HAND IN DOOR

DETAILS OF THE INCIDENT

A contractor, who was operating an Articulated Dump Truck (ADT) stopped the vehicle in heavy rain to pick up a pedestrian and transport him to his light vehicle at the base of the quarry. While sitting down in the passenger seat, the passenger closed the door of the ADT; however, the Operator's left hand was on the door frame to assist with leverage (to then reach across with his right hand to pull the door from the seated position). The passenger closed the door, trapping the Operator's hand between door and frame, causing laceration to the Operator's index finger. The Operator attend hospital where his finger nail was removed and stitches applied.



KEY FINDINGS

- The risk assessment had not identified this potential hazard.
- The passenger and ADT Operator did not communicate regarding the closure of the door.
- The position of the door handle led Operator to an unusual movement when in seated position.
- The weight of the door required some force to close.




KEY REVIEW POINTS

- Brief Operators regarding potential pinch point between door and frame.
- Review risk assessment for access/egress from cab.
- Review pedestrian and vehicle management in changing environments (weather and quarry development).
- Review first aid provisions for access to running water.
- Communication between Operator and passengers.
