Safety Time Out – Think As We Enter Winter



The severity of recent incidents in the EMEA Region has caused some concern. They include a colleague who required surgery after a steel pin went in his eye, a driver who fractured her sternum when her vehicle left the road and, in the UK, a cyclist who suffered injuries described as "life changing" in a collision with a truck mixer and a slip/trip/fall incident where a driver fractured their ankle.

In response to these incidents, a "Safety Time Out / Briefing" has been prepared and management teams are encouraged to coordinate plans to cascade it to their teams. In particular, highlighting the increased risk of slips, trips and falls as we approach the winter months, encouraging everyone to ensure they are prepared:

- Is your site ready for winter? Do you have stocks of grit-salt, de-icer and PPE? Is lighting adequate and are arrangements in place for frost protection and clearing/gritting areas?
- Is your vehicle ready for winter? Have you checked the fluid levels, including de-icer? Do you have an emergency kit and are your tyres, brakes, lights and mirrors all regularly inspected?
- Are you ready for winter? Make sure you wear warm / reflective clothing (hi-vis on sites) and appropriate footwear. Use dedicated walkways and always Get a Grip on steps and stairways.

Don't Slip Up.....



The recent Safety Alert issued by the Health & Safety team shows how serious a 'simple' slip, trip and fall injury can be.

A truckmixer driver recently slipped and fractured their ankle. The ankle required surgery resulting in nine pins being inserted and it is anticipated they will be off work for up to three months. In addition to the pain and suffering from the incident, as a contractor they may also lose out financially in the run up to Christmas.

Please use the Time Out Briefing and Safety Alert to encourage everyone to **Look After Themselves** and Each Other, to TAKE 5 and STOP & THINK before starting a new task, and STEP IN if anything looks unsafe. CEMEX Go Helps Redevelop Leicester



In September 2019 we started working with 4D Structures Ltd on part of Leicester's Waterside Regeneration Project.

Essentially the area has been cleared except for a few listed buildings with new housing, apartments and office space replacing them. A hidden gem located to the North-West of the city centre, it has seen investment in upgraded towpaths and new moorings at Friars Mill which are also contributing to an enhanced and more accessible River Soar and Grand Union Canal side environment.

4D Structures were appointed by the main contractor, Watkin Jones Plc, as their groundworks/concrete frame sub-contractor in September 2019.

The site was compact and split into two separate buildings, a brand-new student home, The Tannery, which offers students modern en-suite rooms in shared apartments, and The Arches, with 184 brand new ready-to-rent private apartments.

We supplied almost 14km3 of concrete from our Humberstone Lane plant, mainly C40 and C50 20 IIB-V+SR S4 Pump + splas for the foundations and floor/column structures, with CEMEX Permatite 40 waterproof concrete for the basement and lift pits. Starting in September 2019, we completed the main pours by August the following year after a brief stoppage for COVID.

An excellent project which in the main went exceptionally well. A tight site with restrictive access via a one-way system, occupied business premises and apartment blocks were close by.

4D were well organised and placed their orders via our CEMEX Go app. This enabled them to place up to two weeks worth of pours via the app thus giving us time to organise both transport and materials prioritising critical pours.

Big shout out to Gav Walker, Aggregates and Asphalt Transport Planner, who has received positive feedback from two Asphalt customers – East Coast Construction and Maher Millard – both of whom mentioned how exceptional his customer service is. Dry, Bagged, Sprayable Concrete.... whatever next?!



Our Dry Silo Mortar team have been supplying dry bagged sprayable concrete to customer, Gunform, for the first time ever. Alex Thomas, Internal Sales Executive for Bagged Mortar, let us know the background:

"This is something CEMEX Dry Silo Mortar hasn't supplied before and is a specialist product we have been working on perfecting. The product we are supplying is a Sprayed Concrete in a dry form in bulk bags.

We are currently supplying Gunform on two of their projects in Scotland, one in Dumfries and Galloway and the other in Inverness. They have committed to us supplying all sites going forward for this material. By the end of next week we will have supplied 290 bags over a four week period!"

Congratulations to everyone involved in bringing this product to market and clinching the contract with Gunform.

Salfords Super New Screen



The team at Salford Asphalt plant are very happy to receive the investment in a new screen on site. It represents a large investment in the plant and is a state-ofthe-art water cooled screen designed to increase the life of the bearings, reduce servicing and therefore downtime.



This type of screen is used to size aggregate on the asphalt plant and replaces the 20 year-old unit that had reached the end of its useful life.

The replacement screen is part of our long-term maintenance strategy before catastrophic failures occur.

Global Industry Commitment to Cut CO2 Emissions



Forty of the world's leading cement and concrete manufacturers recently join forces to accelerate the shift to greener concrete by pledging to cut CO₂



emissions by a further 25% by 2030, marking a decisive step in the race to 'Net Zero' concrete by 2050. Whilst CEMEX has already committed to this individually, it is the first time a global group pledge has been made.

The move by the members of the Global Cement and Concrete Association (GCCA) marks the biggest global commitment by an industry to net zero so far – bringing together companies from the Americas, Africa, Asia, including India and China, and Europe. It follows the September announcement during New York Climate Week that the GCCA has become the first global 'heavy' industry accelerator for the UN's global Race to Zero. GCCA members account for 80% of the global cement industry volume outside of China, and also include several large Chinese manufacturers.

The GCCA has published a detailed roadmap which sets out the path that the industry will follow to fully decarbonise by 2050, a target aligned with the Paris Agreement to limit global warming to 1.5° C. The roadmap actions between now and 2030 will prevent almost 5 billion tonnes of carbon¹ from entering the atmosphere compared to a business-as-usual scenario, equivalent to the CO₂ emissions of almost 15 billion passenger flights from Paris to New York.

Concrete is the most used human-made material on the planet with approx. 14 billion cubic metres produced every year for use in everything from roads to bridges, tunnels to homes, and hydropower installations to flood defences. Concrete is an essential element of construction, with no other material equalling its resilience, strength and wide availability. Production of cement, the key ingredient in concrete, accounts for around 7% of global CO₂ emissions. The new 2030 commitment by the GCCA outlines a significant acceleration in the pace of industry decarbonisation.

TRUCKMIXER DRIVER FRACTURES ANKLE ON CUSTOMER SITE...

DETAILS OF THE INCIDENT

A contract mixer truck driver delivered concrete to a customer site, the driver had completed the pour and parked his truck in order to clean his chutes. Whilst attempting to reattach his chutes on the side of the vehicle, the driver stood on a pile of waste concrete / debris located on a grass bank. Unfortunately the loose debris gave way beneath him, this caused the driver to loose his footing and fracture his ankle. The driver was hospitalised and underwent an operation resulting in 9 pins being placed into his ankle; it is anticipated he will be off work for up to 3 months.





KEY FINDINGS

- There was limited space around the vehicle
- The driver was wearing the correct boots
- The waste pile was not identified as a possible hazard
- The driver stood on unstable ground when attempting to attach his chutes
- The vehicle was parked too close to the waste pile
- MYSPACE training had not been refreshed recently

HOW COULD THIS HAVE BEEN AVOIDED?

- By parking in an alternative area free of debris
- Consider where we are putting our feet use safe access routes
- **STOP & THINK** before proceeding with the task

KEY REVIEW POINTS

- Are **MYSPACE** principles followed especially on customer sites?
- **TAKE 5** do we stop and think, ensuring our work area is safe before completing a task?
- Do we ensure we are proactive in
- identifying and communicating hazards
- and risks especially on customer sites?
- Do we complete dynamic risk
- assessments when required and plan accordingly?

Look after yourself and each other

Don't let anyone act unsafely, always stop unsafe practices.

Housekeeping

Keep designated access routes and work areas tidy and free from trip/slip hazards.

Incident/Hazard alerts

Report all incidents/hazards immediately.




We have continued to make progress with developing our H&S culture this year but still have room for improvement!

8 LTI's occurred between July – Sept this year, some resulting in severe injuries






When addressing any hazard, are the ERICP principles applied?
