Landscape Scale Collaborations with RSPB Business Partnerships



Often, we talk about how nature requires a wider connected network outside of reserves to survive and thrive. CEMEX/RSPB are working to put that connection into action!

Representatives from an AONB, a CEMEX Kensworth quarry, golf course, and their respective RSPB partnership counterparts met recently to discuss the landscape opportunities available and how we progress and work together on these chalk sites. The vision is of habitats that extend and complement each other across all land uses. On the golf course, areas out of play already provide some fantastic wildflower areas and dense scrub. Future restoration plans for the quarry includes extensive chalk grassland, butterfly banks areas of bare chalk that will naturally succeed creating pioneer / early successional habitat along

with ponds and scrub. This combination of habitats provides habitat for a range of species including those scarce and declining species that are known to occur locally like Duke of Burgundy and in the recent past Turtle Doves.

The Chilterns AONB extends from Reading up to Luton and at its northern end includes Dunstable Downs and Whipsnade SSSI, managed by the National Trust, these sites are literally just across the road from both Dunstable Downs Golf Course and CEMEX Kensworth quarry. The RSPB has been working with CEMEX for over 10 years and closely with Kensworth over the last two years, to reprioritise their restoration scheme, which was originally earmarked for woodland and agricultural grassland – for a chalk site this would clearly have been a lost opportunity.

Working so closely with the quarry we've generated support from them. A casual conversation by the Site Manager with the golf course next door has built wider connections. Dunstable Downs Golf Course are keen to enhance their site for nature, utilising the skills from RSPB partnerships with the R&A and quarry. The aspiration being to restore their original chalk downland characteristics and chalk grassland species and wildflowers to their 'long rough – as these characteristics were lost due to the graduation towards a parkland course many years earlier.

The RSPB and the quarry have built connections with the BCN Wildlife Trust and contacted the National Trust to facilitate green haying. Combined, the advice and wealth of local knowledge will input into enhancement at both the golf course and the quarry – an excellent result already! However, we have also connected with the Chilterns Conservation Board as part of the Chilterns AONB, linking in with a Chalkscapes landscape bid.

There are always opportunities for different landowners to work together to share knowledge and form that connected network. Certainly, for the partnership RSPB/CEMEX we hope to replicate this working with stakeholders at other CEMEX sites, whether that be working with local RSPB reserve or with other landowners or other conservation charities. WHAT IS "COP26"?





COPs are the annual UN Climate Change Conferences. This two-week summit is an important space for world leaders, negotiators and observers to discuss the climate crisis on a global level and **reach agreements on specific actions to address global warming.**

1 - 12 November 2021

Kyoto Protocol - the first treaty where the Parties committed to **legally binding emission reduction targets** and set the mechanisms for developing nations to also contribute to the carbon mitigation goals

COP15 in 2009


Copenhagen Accord - nations agreed on trying to limit temperature increase to no more than 2°C



COP21 in 2015

Paris Agreement - the first global pledge where all nations committed to **define a plan to limit global warming to well below 2°C** and to pursue efforts to reach 1.5°C

As part of the **Paris Agreement**, every country agreed to communicate their emissions reduction targets every five years through what is known as Nationally Determined Contributions (NDCs). **These targets set out how far countries plan to reduce emissions across their entire economy.**

Advice for drivers encountering protesters on the public highway

Background

A significant recent trend is for protests by environmental activists on the public highway, with the intention of causing disruption to traffic flows around major traffic interchanges such as motorway junctions and in the process generating media coverage. Protests to date have typically involved groups of individuals positioning themselves across the lanes whilst traffic lights are on red, with some individuals using superglue to attach their hands to the road surface.

The protests have been widely reported in the press and the police are attempting to respond to such protests as quickly as possible. Injunctions have also been taken out to deter this type of protest action. However, there have been some instances of drivers intervening themselves by attempting to drag protesters off the road or driving their vehicles up towards them in what could be seen as an intimidatory or threatening manner.

These protests are likely to continue through the COP26 event in Glasgow in November and afterwards. During this period there is a risk that employees either travelling to work or involved in work activities off-site (such as delivering materials) may encounter such protesters. This briefing provides advice on how member companies and their employees can handle these encounters in a safe and courteous manner.





Dealing with Protesters

Employees should be briefed to ensure that they do not provide protesters or the press covering such incidents with social media footage, photo opportunities or sound bites with negative propaganda potential. This is especially the case when employees are in branded PPE, clothing or vehicles.

Everyone with a mobile phone is a potential cameraman/woman, who will be tweeting/blogging to a potential online audience of thousands or millions. To this end, when dealing with protesters all staff should be reminded:

- Always be polite and respectful
- Never be drawn or provoked into confrontational situations
- Never become involved in situations that would put health, safety or lives at risk
- Adopt a slow, deliberate, calm but firm approach to all eventualities
- Display the highest standards of behaviour when dealing with protesters
- Do not attempt to physically remove protesters
- Do not attempt to by-pass the protesters or drive your vehicle towards them
