Site teams are asked to review and improve housekeeping indoors where appropriate, and to look for areas where there is room for improvement.

This week's poster in our new series focuses on – **What does your site say about your standards?** Please display on your workplace notice boards. You can find the poster at the end of this



Managers can find full details of this Inside Housekeeping – Slips Trips & Falls campaign on the UK News download page, along with the before & after template.


We encourage teams to complete a "hazard spotting" exercise focussed on inside housekeeping and capture any issues via the Near Miss / Hazard Alert system. Identifying any areas where there are particular storage problems and using 5S methodology where appropriate to improve standards. It is also suggested we ensure site inspection schemes include formal housekeeping checks (exterior and interior) at least quarterly.

#### Remember: Housekeeping is not a minor issue

- We know our teams work hard and are passionate about what they do.
- However, poor housekeeping can let a site down it gives the impression of a lack of care and attention and a poor culture.
- Visitors could question the commitment of the team.
- Poor housekeeping can also impact morale and our sense of pride.
- And not only that poor housekeeping has serious health & safety implications! It creates risks and could cause accidents.



#### Let's Continue to Talk Menopause.....



One of the focus areas for CEMEX UK's new Wellbeing Group looks at helping those going through the menopause, and those wanting to support loved ones who are.

#### **TFL Evaluation Day**



The CEMEX Supply Chain team were approached in 2021 by working partners, Loughborough University and Transport for London (TFL), to support the consultation process for the next generation of Direct Vision Standard (DVS) which concludes this month.

The next generation of DVS will focus on future technology that is not only more driver intuitive, but reduces false alarms, has a greater built-in reliability/longevity and gives a better scanned coverage area.

Our long-standing commitment to trialling and implementing next generation safety equipment such as the latest radar Vulnerable Road User detection system made the perfect test facility for Loughborough University

and TFL who are keen to see this type of equipment adopted into the next generation.

On 18<sup>th</sup> October the Tilbury Logistics Operation team were invited to present a vehicle at the TFL offices in London, fitted with the new Radar based system for key stake holders to carry out final testing during live operation of the vehicle.

Tilbury Driver, Darren Wood, supported the testing during the day and raised the CEMEX flag to our dedication towards vehicle safety technology and that of the VRU.

Between 14<sup>th</sup> and 20<sup>th</sup> November we will be supporting Brake and their road safety week which is an important part of our annual road safety calendar.

#### 2022 – 2023 Winter Energy Awareness Campaign



In the latest In the Mix podcast Laurence Dagley, Operational Excellence & Business Development Director – West Europe Materials, explained: "Energy is a big talking point across the country at the moment.

Energy prices have risen significantly due to the conflict in Ukraine which means we have a high price for electricity now, but from everything the market is telling us, we're going to see prices rise ever further – specifically over the winter period.

#### **Congratulations Dave and Tom**



Congratulations to Captain Dave Pearson, and Master in Training, Tom Breen, for passing their exams for a Pilotage Exemption Certificate. This will allow them to bring the CEMEX Go Innovation into the Port of Southampton without using the services of a Marine Pilot which would otherwise be compulsory.

They have had to learn the geography of the port and it's approaches in great detail, together with the applicable

regulations and bylaws, then demonstrate this local knowledge in practical assessments on board the ship and in an oral exam with the Harbour Master and a Senior Pilot.

Holding the Pilotage Exemption Certificate will benefit the company in terms of safety, flexibility, and cost saving by eliminating the potentially hazardous transfer of pilots from pilot boat to the ship, ensuring the ship is free to arrive and depart from the berth without having to pre-book pilots (we have had a few occasions when the ship has been delayed due to lack of pilot availability), and reducing port costs.

#### **One CEMEX in UK Marine**



Recently, the first of two UK Marine Senior Officers meetings took place and was an opportunity for everyone to get together face to face to discuss Health & Safety, and update everyone on all things environmental, operational, commercial and logistics, new legislation, projects, business updates and developments.

Kurt Cowdery, CEMEX UK Marine, commented: "It's an opportunity for us to get together face to face, thank our crews

and further build the One CEMEX mentality within Marine. Well done to all involved. We had great engagement, participation, and presentations."



#### **Future Disruption Due to Rail Strikes**



The RMT Union have announced three days of strike action on Saturday 5<sup>th</sup>, Monday 7<sup>th</sup> and Wednesday 9<sup>th</sup> November.

This will affect a number of rail operating companies, including Network Rail, and is likely to cause severe disruption.

In a separate dispute, RMT rail workers at London Underground and London Overground will also strike on Thursday 3<sup>rd</sup> November.

The Supply Chain team is working hard to mitigate the impact to our operations wherever possible and is in contact with the relevant business areas around this.

However, for employees who are planning to use the rail or London Underground network for travel w/c 31<sup>st</sup> November, for instance for meetings or training, it is worth exploring alternative methods of transport or potentially rescheduling.

The Logistics HGV Driver Apprentices visited the DAF Truck Assembly Plant in Leyland to see how our trucks are designed, tested, and built.

The 710,000 sq. ft assembly plant employs over 1,000 people with a current build rate of over 88 truck per day – destined for the UK, Europe, and worldwide markets.

The CEMEX team experienced the production line at full capacity producing the latest models of trucks and a full guided tour of the factory was given, seeing a truck assembled from parts arriving at one end to driving off the

line. The Apprentices witnessed how closely the production teams had to work on the line to achieve the continuous flow along the moving line and the advanced quality control involved and like CEMEX going home safely was central to their operation.

The team at DAF were impressed with CEMEX commitment to train young drivers and we had great feedback from our apprentices on how informative and enjoyable the experience had been.

# ENVIRONMENTAL BRIEFING Bunds and Bunding

#### **Overview**

A bund is a secondary containment system which is designed to capture any leaks or spillages from a primary container such as a storage tank or drum. A bund is impermeable and designed to ensure that any liquid escaping from the primary container is retained in the bund and prevented from spilling onto site or escaping to the environment.

It is recommended to have secondary containment for all hazardous liquid storage as their uncontrolled release may cause environmental damage and create a hazardous working environment. If you have a pollution incident you can be prosecuted, face an unlimited fine and be liable for all clean-up costs under the polluter pays principle.

However as with a lot of environmental issues there are also legal requirements for bunding. The <u>Control of Pollution (Oil Storage)</u> <u>Regulations</u> makes it a legal requirement in the UK to have adequate secondary containment on any external oil storage over 200 litres.

Bunds should be of sufficient size to hold 110% of the largest container within the bund or 25% of the total of all the containers stored. Wherever possible pipes and cables should be run over bund walls and not through the bund walls or floor. If penetrations are unavoidable it is essential to ensure they have a watertight seal installed around the pipe/cable, and the sealant material must be resistant to the product stored in the bund.



To prevent rainwater entering a bund and reducing its capacity it is preferable to install a roof above the bund. Where it is not possible to cover a bund it is imperative an appropriate maintenance regime is in place.



Effective bunds will collect and contain anything which falls inside them, not only the liquid they are designed to capture but also unwanted material such as rainwater. If a bund is not maintained properly the unwanted build-up could reduce the capacity of the bund and may cause it to fall below the capacity requirements. Rainwater and other debris should be removed regularly.

When removing substances from a bund it is essential to test for contamination before they are disposed of. If they are contaminated they will need to be disposed of in line with waste regulations Contamination levels can be very low and still require treating as hazardous waste, for example the threshold for oils can be as little as 0.1%.

As well as regular rainwater removal, periodic checks should be undertaken assessing the condition of the bund walls and floor. If any defects are found it is essential they are repaired as soon as possible to prevent the problems from becoming worse, as even hairline cracks will provide a pathway for liquids to escape the bund and any structural issues can significantly weaken the strength of the bund walls. Defective bunding can be as bad, if not worse, than no bunding, as it can mask leaks and gives a false sense of security. Over time chemicals/oil leaching out of bunds can go unnoticed and lead to serious ground and groundwater contamination. If bunds have developed cracks they will need to be repaired to ensure the bund is not only watertight but retains the structural integrity to withstand a catastrophic failure.

#### **Key Points**

- 1. All liquids with potential to cause environmental harm including oils, acids and admixtures should have secondary containment (even milk can cause harm!)
- 2. Wherever possible bunds should be covered to prevent rainwater ingress
- 3. Bunds require regular inspection
- 4. Bunds must be kept clean to ensure that the capacity is not reduced
- 5. Any leaks, cracks or other damage should be repaired as soon as possible
