Winter Water Safety



The tragic death of three children who fell through ice into Babbs Mill Lake in Solihull is a reminder of the importance of raising public awareness about ice safety and the responsibilities of landowners.

As operators, CEMEX needs to ensure that we have appropriate procedures in place where we have bodies of water that might freeze and where members of the public, particularly children or dog walkers, are known to visit.

On Monday afternoon, the day after incident in Solihull, Jeff Jones, Assistant Quarry Manager at CEMEX's Forest Hill quarry, had to remove four teenagers from frozen water on a restored area. He had heard the teenagers and went over to investigate and found them on the pond on a sledge. They had damaged a warning sign and were using this to slide on the frozen pond. They were reminded about the dangers and asked to leave the site. Subsequently the local ASBO Officer and the Parish Council were informed, who carry out regular checks in the area.

A huge thanks and well done to Jeff for Stepping In quickly to escort the teenagers from site – he may have saved their lives!

We urge all Site Managers to check the following:





- You are aware of sites where water is frozen and members of public may be tempted to enter / visit.
- You have a risk assessment in place that covers this from the perspective of both public safety and safety of employees/contractors.
- If risk assessments recommend the site has throw lines or other safety devices ensure that these are in place.
- Do you have any sites where you perceive the risk to be particularly high where the use of temporary signage warning of thin ice would be appropriate?
- Do the emergency services know how to access your sites should someone be in trouble in water / ice?
- Does your signage give information about exact location and who to call in emergency 999
 ask for Fire and Rescue Service if inland water?

The MPA has been promoting generic water safety messages being issued by safety organisations and emergency services, most recently the "Don't Drink and Drown" and "What to do if you fall through ice advice" (RLSS campaigns) and other winter water safety messages.

With the recent Met Office's yellow weather warnings, temperatures are set to drop as low as minus 15 in parts of Britain, please share the following warnings with your offline colleagues, friends and families. It could save a life!

In an emergency, if you see a person in the water:

- Call 999 and shout for help nearly 40% of people who drowned last year had no intention to go into the water.
- Stay off the ice and away from the edges: help from the land to the best of your ability.
- Shout to the casualty to maintain heat and energy: Float To Live.
- Tell the person to stay still to maintain heat and energy.
- Look for rescue equipment or anything which will extend your reach, such as a rope, pole or branch.
- Reach or throw out to the casualty with it. Gently guide and move the person to the shore. Make sure you are on stable ground.
- Keep the casualty warm and make sure they go to the hospital.

Some facts about smoking:

- There are about 6.9 million adult cigarette smokers in the United Kingdom.
- Overall, the proportion of adults (aged 16 and over) smoking in Great Britain has been declining since 1974 (when national government surveys on smoking among adults first began).
- Across Great Britain, since 1990, there has been a steady increase in the number of smokers using mainly hand-rolled tobacco.
- In general, men are more likely to smoke than women.
- Since 2010, smoking has become less common across all age groups.
- Smoking continues to be lowest among people aged 60 and over.

Update on Risk of Environmental Activism



As many of us will have seen, there have been many recent protests carried out by activist groups such as Extinction Rebellion and Just Stop Oil across the UK.

Between 11th August and 11th November this year, 184 protests were identified across the UK, and 54% of these took place across London. High profile protests have included disruption of heavy traffic routes such as the M25 and the Dartford Tunnel. There has been an increase in the crossover between socialist protest groups focused on the cost-of-living crisis and

environmental activism.

The CEMEX security team works closely with local police forces and security groups to monitor the risk to the business presented by environmental activism. All employees should be aware that it is almost certain that mass protests will become more frequent due to the increase in coalition between socialist and environmental activist groups. It is highly likely such protests will continue to occur as people struggle through the cost-of-living crisis and that climate groups will continue to organise sustained campaigns over consecutive days more frequently.

Research has further identified roadblocks have increased significantly, alongside protests involving vandalism and criminal damage and the use of paint being used to damage buildings has increased significantly. As you may have seen, the inconvenience caused by roadblocks has led to members of the public intervening and attempting to physically remove protestors from the road themselves; activity no one at CEMEX should become involved in.

The Security team, therefore, wanted to take this opportunity to update everyone on the developing threat of environmental activism and urge employees to remain vigilant. Colin Jones, UK Security





Manager, commented: "The news has been full of stories of environmental protests over recent weeks, and those structured around disrupting traffic are particularly impactful to our business.

However frustrating and inconvenient these protests may be, it is crucial that no employee takes matters into their own hands and tries to intervene or remove any protestors they may come across. As always, we ask employees to ensure they follow the guidance in our protest contingency plan and contact either myself or John Sweeting with any questions."

Avoid Mobile Phone Use While Driving



We are approaching that time of year when more people will use the roads to visit family and friends and when people become more distracted thinking about the festive season. We should be mindful of our own behaviour and habits while driving, which includes those trips we make for business purposes and what controls we should follow. This is particularly relevant when it comes to the use of mobile phones while driving.

Research has shown that using any phone behind the wheel makes you four times more likely to be in a crash. This is a sobering statistic. It's important that we maintain full concentration on the road and not be distracted, even when using the phone on a hands-free device. Don't be tempted to join meetings while driving, even when you are only listening – your concentration levels will drop.

Did you know we have a Global Policy for the Use of Mobile Phones While Driving, which you can find in the link below. Although this has been around since 2016, it's still worth familiarising yourself with it again and making others aware of it too. A couple of points to highlight from the Policy:

- · All drivers must avoid phone use unless absolutely necessary.
- · Where it is necessary, then it must be kept to a minimum.

Earlier this year we commenced operations at our new recycling facility at Berkswell quarry near Birmingham.

Through a strategic partnership with HD Ricketts Ltd, one of our key customers in the Midlands, we were able to utilise both their expertise and equipment to start producing recycled aggregates safely, quickly and efficiently. As a result, materials that were being imported in to Berkswell for restoration are now being diverted to the recycling operation to produce a range of materials from recycled sands to construction fills.

Phil Constable, Commercial Manager for Aggregates UK North, said: "The strategic partnership model we have developed at Berkswell allows us to work closely with existing customers and fast track our recycling business safely and efficiently. As we learn, we will quickly develop this model to ensure we grow our presence and expertise in the Circular Economy through Berkswell, thereby contributing to a sustainable future for the business as a whole."

Linking Schools to Local Industry



Groundworks East are a charity working across the East of England to create stronger, healthier communities, responsible business and greater prospects for local people. They are also one of CEMEX UK's Social Impact partners for 2022.

During 2022 Groundworks and CEMEX have worked together on The CEMEX Quarry project. Funded by CEMEX UK and organised by Groundworks East, the project took place between March and October 2022 with Green Lanes Primary School, St. Philip Howard

Primary School, Birchwood Avenue Primary School, Oakview Primary School and Onslow St. Audreys Secondary School.

All five schools are based in Hatfield, Hertfordshire. The schools were chosen due to their proximity to CEMEX's Hatfield quarry. The programme for all schools included a visit to Hatfield quarry and Amwell Nature Reserve, and two classroom sessions.

The project was a great success; it gave the children opportunities to learn about industry on their doorstep and provided them with 'real life' examples, through exploring and comparing a working quarry to a guarry which had been restored as a nature reserve.

The children took part in activities such as fossil making, bird watching, sketching and role playing and debates. The activities allowed the children to: learn about local industry and the process of quarrying; learn about local wildlife and the impact on the environment from quarrying; and gain knowledge about





local geology and the formation of fossils. The children took a great interest in learning about their local area as shown by their enthusiasm to research further into the topic at home and in school.

The project has proved to be very popular with local schools that see it as a great way of meeting many requirements of the National Curriculum.

Here is some of the feedback from the participating schools:

"The children from Green Lanes have loved their visits to CEMEX quarry and Amwell Nature Reserve. It has allowed them the opportunity to experience different environments that some may not have been able to experience before. They were able to see first hand the impact of quarrying and the resulting positive impact it can have. This helped bring their learning to life and spark a range their enthusiasm to learn more and ask questions."

UK Environmental Briefing



The Sustainability team have created the latest Environmental Briefing highlighting the importance of continuing legal compliance on our sites, including during times of business change, which has been highlighted as an area of concern during both internal and external environmental audits. This is also particularly relevant as we approach the holiday season as we are still expected to maintain

legal compliance whilst our sites are closed or at reduced operational capacity.

Managers, please can you ensure that you bring this to all our employees' attention and that this is shared on notice boards where appropriate so that those who aren't online also have access to this message.

As part of the HR Evolution | Working Smarter initiative, we are continuing to work on delivering a better workforce experience around our operations.

Starting this month, Tata Consultancy Services will be our new provider for Payroll, supported by Ernst and Young (EY). Through this new partnership we will leverage digital technologies to become more efficient in our services. This means that we will be making some changes to how you view your payslip.





Online Payslips

Starting this month, if you currently access your payslip online through Shift, your payslip for December pay (paid on 3rd January) will instead be available by accessing the EY Interactive Portal (IP) and mobile app. Your payslip should be available for you to view by 28th December.

In the next few days, you will receive a welcome e-mail from EY that will contain information about how to enroll on their portal and how to use it.

Historical payslips (from November 2022 and prior) will still be available in Shift if you need them.

Paper Payslips

For employees who currently receive their payslip through the post, this will continue, although your payslip may look slightly different. In due course and as our HR Evolution continues, we expect that all employees will eventually be able to view their payslips online.

Keep your registration number and payment details up-to-date and double check that they're correct on any Auto Pay apps or accounts, e.g. make sure you're using '0' instead of '0'



Waiting times

Be vigilant and check for any signage about parking restrictions and make sure you pay the appropriate fee and check the wait times



Parking Apps

Make use of the parking App reminders allowing you to return on time and give you the option to extend if you're running late



Safeguard

If you breakdown, keep all your paperwork safe just in case you need it for a future appeal

Reminder: Future Disruption Due to Rail Strikes



A reminder that the RMT Union have announced a series of **48** hour strikes on:

- Friday 16th and Saturday 17th December
- Saturday 24th (from 18:00 GMT) until Tuesday 27th December
- Tuesday 3rd and Wednesday 4th January
- Friday 6th and Saturday 7th January

This will affect a number of rail operating companies, including Network Rail. The disruption this is going to cause to our

business is significant. Please can you ensure you are advising customers of the potential impact to supply, especially as many of our depots are critically low on stock due to the action so far this year.

The Supply Chain team is working hard to mitigate the impact to our operations wherever possible and is in contact with the relevant business areas around this.

However, for employees who are planning to use the rail network on the above dates, for instance for meetings or training, it is worth exploring alternative methods of transport or potentially rescheduling.

KEEP SAFE THIS CHRISTMAS



- Where appropriate, ensure company cash is banked prior to the holiday and not taken home for safe keeping or left in the safe.
 If an onsite safe is otherwise empty, leave the door obviously ajar.
- Ensure all windows and doors are closed and locked. Lights and electric heaters are turned off unless there is a pressing reason for leaving them or lights are part of the night time security measures.
- Any site, mobile plant and vehicle keys are preferably taken off site or suitably secured preferably in a safe.
- Safe keys are taken home and not hidden.
 Site radios and chargers should be hidden or locked in the safe.
- Gate and office keys should not be hidden outside. If an authorised member of staff needs access to the site they should take a key with them.
- For CCTV sites monitored at Coventry, ensure your key holders are notified to the control room (ukcctv.security@cemex.com).
- Per usual practice, staff on site during the holidays must notify the control room when they enter and leave the site. Failure may result in the police or key holder being called.
- The Coventry CCTV Control Room will be staffed throughout the holidays, from 1800hrs Friday 23/12/22 to 0600hrs Tuesday 3/1/23. (Tel: 01788 517377)
- Where possible, valuable personal possessions and tools should be taken off site, (they are not covered by the Company insurance) including, personal possessions in trucks and company car.

- Laptop computers should not be left in car boots or behind the back seat. This applies at all times, especially if socialising after work or visiting the shops or gym on the way home.
- If you have gas oil or fuel tanks on site, leave as little as possible in the tank, and don't get a delivery just prior to the holiday. Move any bowsers into as secure a location as possible and secure any containers (water cannisters, ad mixtures containers etc..) and wheelbarrows that could be utilised to carry away syphoned fuel. If containers are not otherwise recyclable, consider puncturing to prevent misuse.
- Vehicles, trucks, and mixers...leave as little fuel in as possible. If able to do so move vehicles off unmonitored sites. Vehicles left on site should be parked tank-to-tank or battery-to-battery to frustrate offender access.
- Take steps to bury and protect all cabling and other copper assets. Cabling not in use should not be stored on site.
- If an intruder alarm is fitted to a building make sure it is set and operates correctly. If the gate is secured by a combination padlock ensure that Coventry CCTV office has the correct code (ukcctv.security@cemex.com).

What to do if you fall through the ice:

- 1. Keep calm and shout for 'help'
- 2. Spread your arms across the surface of the ice in front of you
- 3. If the ice is strong enough, kick your legs to slide onto the ice
- 4. Lie flat and pull yourself towards the bank
- 5. If the ice breaks, work your way to the bank-breaking the ice in front of you anyway
- 6. If you cannot climb out, wait for help and keep as still as possible. Preserve heat by pressing your arms by your side and keep your legs together. Keep your head clear of the water
- 7. Once you are safe, go to hospital immediately for a check up

What to do if you see someone fall through the ice:

- 1. Shout for assistance and phone the emergency services call 999 or 112
- 2. Do not walk or climb onto the ice to attempt a rescue
- 3. Shout to the casualty to 'keep still' and offer reassurance to keep them calm
- 4. Try and reach them from the bank using a rope, pole, tree branch, clothing tied together or anything else which can extend your reach
- 5. When reaching from the bank, lie down to avoid being pulled onto the ice
- 6. If you cannot reach them, slide something which floats, such as a plastic bottle or football, across the ice for them to hold onto to stay afloat whilst help is on the way
- 7. If the casualty is too far away, do not attempt to rescue them. Wait for the emergency services while calming and reassuring the casualty

What to do after the casualty has been rescued from the ice:

- 1. Make sure the ambulance is on its way
- 2. Lay the casualty flat, check for normal breathing and begin resuscitation if necessary
- 3. Prevent them from getting colder by covering them with warm clothing, blankets etc.
- 4. Get them out of the cold under cover or create some shelter around them
- 5. Until the casualty is in a warm place, do not undress them
- 6. Do not rub their skin, do not apply hot water bottles and do not give an alcoholic drink
- 7. Keep them wrapped up so they warm up gradually

ENVIRONMENTAL BRIEFING

Legal Compliance

Introduction

During this year's round of external ISO 14001 audits several NON-CONFORMANCES and OBSERVATIONS were raised for breaches to conditions of our environmental permits, e.g., PPC Permits, Trade Effluent Discharge Consents & Surface Water Discharge Consents, as well as broader legal compliance issues such as with Waste and Oil Storage Regulations. The Sustainability Department have also picked up on these issues during our own internal audits. We have all faced a great deal of disruption to our normal working lives over recent years because of COVID, the Breedon divestment and subsequent management reorganisations, which have all been unavoidable and mostly unexpected. However, we need to remind all areas of the business that regardless of these changes we must remain LEGALLY COMPLIANT with our licences to operate as well as all other legal requirements. This will allow us to avoid damage to the environment, fines and damage to our reputation and customer confidence.

Examples of Issues

- A non-conformity raised by our external auditors daily dust, maintenance or other environmental checks not being carried out
 either partially or not at all. It is essential that environmental permit checks are carried out on time and as required. If we had
 an environmental incident or received a complaint at a site where no permit checks were completed it is much more likely the
 regulator would take enforcement action against us as we would not be able to prove we were otherwise complying with our
 permit.
- Completing PPC Permit checks incorrectly. It is important not to assume everything is working as it should without physically checking. There was evidence from audits which showed the daily dust checks were being marked as OK, when clearly there were issues.
- 3. Contamination in hazardous waste bins. It is a legal requirement to ensure waste is properly segregated. Audits identified cases where non-hazardous waste was found in hazardous waste bins. This issue also has a cost implication as it much more expensive to dispose of hazardous waste. Hazardous waste in a non-hazardous waste bin is also illegal.
- 4. Another non-conformity raised by our auditors it is a legal requirement that hazardous waste bins are emptied at least every 12 months. There was evidence at sites where hazardous waste bins had not been emptied for several years.
- 5. Changes to plant layout or structure before authorities have been notified. It is essential that proposed changes to a plants operation e.g., new silos, new aggregate bays, new fuel type (Asphalt), meters, or any new equipment are notified to regulators and permission granted to ensure we remain legally compliant.
- 6. Housekeeping ensure old oil or admixture drums (empty and full) are sent for disposal and not allowed to build up on sites where they can accumulate for years. It is also essential that oil and chemicals are stored in a way that is compliant with the oil storage regulations i.e., on or in an adequate bund.

Key Points

- Ensure sites are compliant with environmental permit conditions including in relation to dust checks and potential emissions.
- Hazardous waste must not be contaminated with non-hazardous waste (or vice versa) and bins/boxes need to be emptied at least once per year.
- If there are changes to plants, ensure the regulator is notified so permits/consents accurately describe our operations.
- Housekeeping don't let oil or admixture drums (full or empty) build up on site or remain for periods longer than 12 months.
 Ensure all drums and bulk tanks are properly bunded.
