Latest Safety Alert



The latest Safety Alert and Video Safety Alert relates to an incident in our UK Operations last year. A contract tipper driver suffered injury to his hands when they came in contact with hot asphalt at a temperature in excess of 150°C.

While there are learning points specific to the local operations, there are also discussion topics that would benefit teams more generally, including:

- Do we have suitable designated areas for sheeting, tip off, material sampling, etc... flat, well-lit, and segregated from traffic routes?
- Are there any work areas where we need to improve drainage to avoid ponding water and the increased risk of slips, trips and falls?
- How do we ensure perceived pressures don't cause people to rush, with an increased risk of injury?
- Are necessary Safe Systems of Work in place and communicated to relevant personnel?
- How do we ensure people are trained and competent to operate equipment, for example the vehicle self-load equipment in this case?
- Where we have a recurrent process issue, such as vehicle overloading, is it highlighted (Near Miss / Hazard Alert) and remedial action taken before an incident occurs?





 Does everyone follow the Safety Essentials, and do we Step In / Take 5 Together where we see something unsafe? In this case, the driver used the wrong tool for the job, was not wearing gloves and risked infection by washing his burnt hands in a puddle.

Please discuss the Safety Alert and Video Safety Alert with relevant members of your team and consider whether there are any improvement opportunities that could be implemented locally to prevent future injuries.

Remember! Before starting a new task, **TAKE 5** to ensure you STOP & THINK and ensure it is safe, and always **STEP IN / Take 5 Together** if you see anything unsafe.

- In general, men are more likely to smoke than women.
- Since 2010, smoking has become less common across all age groups.

Major Readymix supply in Manchester



Late last year, CEMEX North West Readymix successfully completed the supply of 10,000m3 of Readymix concrete from our Manchester plant for a major project for BAM Construction.

The project, the new £68 million trauma unit at Salford Royal Hospital, once completed, will receive 90% of all major trauma patients in Greater Manchester and will include a resuscitation area, five emergency theatres, inpatients beds, and diagnostic imaging. It will be a hub site for high-risk emergency general surgery and also a new helipad to ensure patients receive timely treatment with an anticipated 360 landings every year.

Very Prompt Delivery of Promptis



This week, CEMEX UK North East delivered just over 60m3 of CEMEX Promptis rapid setting concrete into Esh Winning in Durham for a returning customer. In total we will deliver around 150m3 on completion. A huge thank you to our fantastic operations and fleet team as the whole lot was in before 12pm.

The reason for Promptis? The haulage company needed a quick turnaround in getting the concrete poured and ready for practical use. Our rapid hardening concrete is the perfect solution to save

valuable hours as it can achieve strengths up to 40N/mm2 in 24 – 48 hours.

This pour was tracked on CEMEX Go giving full transparency to the customer throughout the morning, further helping save and utilise time.

Dove Holes Recycling Takes Off!



As part of our efforts to contribute to the Circular Economy, various materials such as scrap blocks, returned loads of concrete etc. that had built up over a number of years at Dove Holes were reviewed and identified as potentially recyclable.

In order to move fast and produce results we partnered with one of our key customers, Ashley plant, to campaign crush and screen the material. Through utilising Ashley plant's experience and equipment we were able, at no cost to the business, to

quickly produce a saleable fill material from what was a problem stockpile of waste material.

Ian Robinson, Sales Executive for Aggregates North West, commented: "Much of this material has now been sold to the local market direct by CEMEX thereby proving that a problem waste stockpile is in fact an opportunity, and just of one many ways to help meet our aim of being a sustainable Circular Economy business."

Halkyn Donation Rocks!

Marine Increases its Reserve Portfolio



As part of developing our CEMEX Marine Strategy, our marine reserve base has recently been extended with the renewal of the Marine Licence for our marine extraction area West Bassurelle (Area 458/464), located in the eastern English Channel. The area has been dredged since 2007 with cargoes delivered to aggregate wharves on the Thames and near Continent.

Marine Licences are determined by the Marine Management Organisation, the regulator for marine works in England, which

includes mineral extraction. The renewal has been several years in development and planning, with various environmental studies, consultation and an EIA undertaken.

The new Marine Licence for this important area allows the extraction of up to 30 million tonnes of sand and gravel from the seabed, for a further 15 years.

Quality Matters Update



We have recently experienced a number of instances where changes in delivery vehicles at the last moment have potentially led to material being delivered to the incorrect customer.

To speed up the production process, deliveries are often assigned to a vehicle in advance of the vehicle being in place to load, however,

we must always ensure the correct vehicle is in place before loading commences. Where CEMEX Go is in use and ticketless deliveries are taking place, the potential for errors in this area also exists and is perhaps more prevalent.

QuM-1013 has been produced to highlight the steps that need to be taken in CEMEX Go to prevent incorrect ticketing and potential high liability to the business. 
Do You Use Macros?



Starting January, Microsoft will gradually modify the default settings on its Office apps globally. For security enhancements, macros will be blocked in all files. This change prevents malicious actors from gaining access to deploy malware.

A macro is a small program or set of actions that you can run repeatedly within an Excel file.

The next time you open a file (applies on previously created and new files) the following message may be displayed:



It is important that macros remain blocked as default as far as possible. Do not unblock if you have any concerns or are uncertain about the file's origin.

SAFETY ALERT

DRIVER SUFFERS ASPHALT BURNS

DETAILS OF THE INCIDENT

A contract tipper vehicle was overloaded with asphalt and the driver had to tip off a small amount in the designated area. After doing so, the rear door was prevented from closing by product loaded towards the back of the vehicle body. The driver used a tool / bar, which should only be used to open the tailgate if it fails to open automatically, to try and force the tailgate shut; the bar slipped and his hands momentarily came into contact with the hot asphalt below. First aid was administered on site and the driver went to hospital later in the day. He was able to carry out restricted duties the next day and returned to full driving a few days later.

KEY FINDINGS

- The overloading of the vehicle wasn't an isolated incident.
- The driver self loaded the material too close to the tailgate.
- The tip-off area is located in a busy part of the site, with limited space for the driver to move the vehicle forward after discharging the materials on to the floor.
- This particular vehicle had an unusual / bespoke tailgate and the driver used a tool / bar that wasn't suitable.
- The driver was not wearing gloves during this activity.
- The quick actions of the site staff to administer first aid reduced the severity of the driver's injuries.

HOW COULD THIS HAVE BEEN AVOIDED?

- Vehicles are not overloaded and product isn't sitting against the tailgate.
- Ensure people are trained and competent to operate equipment.
- Wear gloves for all manual activities.
- Ensure safe systems of work are in place to include activities such as this.








KEY REVIEW POINTS

- How often are vehicles overloaded can this be eliminated or at least minimised?
- Do drivers understand loading processes, avoiding loading too much product towards the rear of vehicles?
- Do drivers and operators wear the correct gloves for manual activities?
- Are onsite tip-off areas in a suitable position, away from busy traffic / pedestrian routes and other workplace hazards, and well lit?
- Is there a safe system of work for drivers carrying out this type of task?

ASSIGNING THE CORRECT VEHICLE TO A DELIVERY

Delivery of the wrong material/to the wrong site can be extremely costly to our business.

In order to speed up the production process, deliveries are often assigned to a vehicle in advance of the vehicle being in place to load, however, we must always ensure the correct vehicle is in place before loading commences. Where CEMEX Go is in use and ticketless deliveries are taking place, the potential for errors in this area also exist and are perhaps more prevalent.

Example

A load is assigned to Truck A and the driver has assigned the load to their device.

Truck A realises that they have a puncture and is unable to take the load, so Truck B (next available vehicle) needs to be assigned. The Plant Manager needs to update the vehicle details in the Delivery Maintenance tool as soon as possible and advise the driver of Truck A to remove the delivery from their device.

Only after this has been done should the Plant Manager advise the driver of Truck B to add the ticket to their device. The ticket should pull through onto their device automatically when the driver has selected "add". If this doesn't happen then the driver may request some additional information i.e., ticket number and customer number to complete a verification step in the app

When an incorrect vehicle is assigned to a delivery

- 1. Update vehicle details in Delivery Maintenance as soon as possible
- 2. Contact the driver of the original vehicle, explain that the change has occurred and advise them to remove the delivery from their Driver App (if they had already assigned it).
- 3. Contact the driver of the correct vehicle and advise them to add the delivery to their Driver App. (This can only be done after the change in delivery maintenance has been made and after the original driver has removed the load from their device)
