Latest UK and Global Safety Alerts



UK Safety Alert

The latest UK Safety Alert relates to an incident last month in the UK where a colleague suffered tendon damage to his ankle as he stepped down from a forklift truck, causing him to have to take time off work.

As you will see, the injured person exited the cab of the forklift forwards rather than backwards with three points of contact, when his foot slipped off the lower step landing on a wooden baton.

The local team are reviewing whether any improvements can be made to the production processes to eliminate or reduce the potential for further injuries of this nature, however, the incident acts as a reminder of the importance of promoting and following the Safety Essentials, particularly the need to "Get a Grip" and maintain three points of contact when getting in and out of vehicles.

The investigation identified it is not uncommon for operators at the site to forget to exit their cabs facing their vehicles with three points of contact; by promoting a culture where team members **STEP IN**





if they see a colleague at increased risk of injury due to unsafe conditions or behaviours, we can all Look After Ourselves and Each Other, our #1 Safety Essential!

Please discuss the Alert with your teams, taking time to consider if there is anything you can do collectively to reinforce the Safety Essentials and STEP IN / Take 5 Together culture.

Thankfully, our colleague has made a good recovery and is back at work.

Global Safety Alert

The latest Global Safety Alert relates to the death of an employee outside of the EMEA Region who was tragically struck by a rail wagon while tidying the sidings at a Cement Plant.

In addition to ensuring personnel are:

- Suitably trained and competent in the work they are required to do.
- With a good knowledge of the relevant procedures.
- Are effectively supervised.
- Apply the specific learning points detailed in the Alert, which includes the need to restrict access to danger zones and use Permits to Work as appropriate.

The following points may also be relevant to rail operations:

- Do personnel require formal training, such as Rail Safety Awareness Training, or Personal Track Safety Training?
- Where people are working alone, is a second person required to act as a lookout?
- Do personnel have radio contact with a designated Person in Charge?

Please discuss the Alert with your team and review if action is required to close any gaps in local procedures.

Cemex Global Protocols require all Fatal Alerts to be communicated and Managers to capture the signature of employees and contractors to confirm they have received and understood the information and the control measures they need to adopt. In addition, operations are invited to observe a one-minute silence in memory of the deceased at the time of discussing a Fatal Incident Safety Alert.

Before starting any new task always **STOP**, **THINK... & CHECK** it is safe, and always **STEP IN** if you see anything unsafe.

New Evacuation Alarms for Midlands Plants



Over the past few months several Midlands plants have made significant Health & Safety improvements by implementing effective ways of raising an alarm in high-risk areas.

Rugby Cement plant, along with Coventry, Berkswell, Weeford and Pyford Readymix plants, have all benefited from new evacuation alarms, emergency contact signs and eye wash stations, placed at focused areas:

- Outside mixer rooms
- Cement blow up pipes

- Canteens
- Testers labs
- Offices
- Batch cabins and on evacuation routes

With the installation of the new alarms, multiple alarms, if necessary, can be activated upon evacuating the area. These are not just for fire but any emergency or medical issue that may arise.

These have also been added to Checkproof for monthly battery tests along with the fire alarms.

The teams have also implemented visible staff photos on noticeboards and any information that may be needed near car parks for visitors to view before meeting staff on the plants.

Brighton Goes Solar





Cemex's Brighton Wharf has recently had 66 solar panels installed on the roofs of its main offices and weigh bridge (154 metres square).

This initiative is to harness solar energy for office use, providing an estimated £19,000 savings on solar panel lifetime use. This is part of Cemex's long term strategy to decarbonise our operations.

During the first 18 days after installation the panels produced nearly 2Mwhs of energy, instead of taking energy from the grid. This equates to around 366kg of CO_2 savings.

Many thanks go to the Engineering team, Operational Excellence and the site staff for their collaboration with UK Capex Procurement to help deliver this project.

A Grape Year for Wine Quality!



Cemex's restored quarry in Castillejo (Toledo) in Spain, which supplied limestone to the cement factory for almost 100 years, was converted into a 92,000-plant vineyard, producing high-quality Merlot, Syrah and Cabernet Sauvignon grapes.

This year, as a result of the high temperatures and the lack of rain in the region, the harvest has been lower than other years, however, experts say that these extreme conditions reduce the amount of grapes but have improved their quality.

54,000 kilos of grapes have been collected, which will become an excellent wine!





Investment into UK Asphalt Business



Cemex is making strong progress with a significant investment programme into its UK Asphalt operation. This includes the opening of a new plant in Birmingham, as well as developments at several locations to ensure a more efficient and more sustainable operation with smoother product delivery for customers.

The new plant, located on Doris Road in Birmingham, will allow Cemex to better target this key urban market with its array of Asphalt solutions.

Products that will be produced on site include RUBBERMIX ASPHALT (RMA), which incorporates crumb rubber granules taken from used tyres into the mix, helping to offset the environmental impact of highway maintenance activity through the circular economy; and VIALOW, Cemex's low temperature, reduced carbon asphalt which comes with the option to offset residual CO2 to make it a CarbonNeutral® product, in accordance with The CarbonNeutral Protocol, will also be produced at this new location. Further trials are underway on other more sustainable asphalt products that prioritise circularity.

The new Birmingham site will operate as a Local Asphalt plant, providing a dedicated service for customers that require small tonnage collections and deliveries, stocking everyday essentials such as tools and equipment needed to provide a first-class service.

Scott Jones, Director of Asphalt for Cemex UK, commented: "We are making a considerable investment into our asphalt portfolio with the opening of our new Birmingham location and development programme at our existing sites, but this is indicative of the continued success of our Asphalt business and our commitment to this product line. Cemex hopes that these investments will improve the efficiency of our UK asphalt operations and enhance product delivery for customers, while better serving key metro markets."

It's 'Know Your Numbers' Week



This month our Wellbeing focus is **Know Your Numbers**. During September we will be sharing information and resources about blood pressure, cholesterol, balanced nutrition and alcohol.



The national campaign **Know Your Numbers Week** is taking place this week. The aim is to raise awareness and share resources around **high blood pressure**, a major risk factor for

heart disease and stroke.

Here are some of the reasons why everyone should check their blood pressure numbers.

- 1 in 2 strokes and heart attacks are the result of high blood pressure.
- 1 in 3 adults in the UK have high blood pressure.
- 1 in 2 adults with high blood pressure don't know they have it or aren't receiving treatment.
- 6 million people in the UK alone have high blood pressure and don't know it.
- £2.1 billion that's how much high blood pressure costs the NHS every year.

Because high blood pressure usually has no symptoms, the first sign of it could be a <u>heart attack</u> or <u>stroke</u>. It can cause kidney disease, dementia, and other illnesses too. But these tragedies can be prevented with <u>medications</u> and <u>lifestyle changes</u>.

Finding out your numbers

The only way to know if you have high blood pressure is to have yours measured. However, a single high reading does not necessarily mean you have high blood pressure. Many things can affect your blood pressure through the day, so you will need to see that it stays high over time.

How is blood pressure measured?

Your blood pressure is usually measured using a blood pressure monitor. This is usually an electronic monitor connected to an inflatable cuff, which is wrapped around your upper arm. When you have your blood pressure measured, the reading is written as two numbers. The first is when the pressure is at its highest (or systolic pressure), and the second at its lowest (or diastolic pressure). For example, your reading might be something like 140/90 mmHg, which you would say as "140 over 90" (mmHg is a unit for measuring blood pressure).

Around Cemex UK many of our offices and sites have blood pressure monitors for you to use to check your blood pressure, your Supervisor should be able to advise where they are located. Check out this useful guide on how to take your own blood pressure reading – click <u>here.</u>

If you don't have a monitor at your workplace, some pharmacies and GP surgeries also have blood pressure monitors for you to check your blood pressure.

What do the readings mean?

As a general guide:





- Normal blood pressure is considered to be between 90/60mmHg and 120/80mmHg (this applies if it's measured at home or at a GP surgery or clinic).
- High blood pressure is considered to be 135/85 or higher if your reading was taken at home, or 140/90mmHg or higher if your reading was taken at a GP surgery or clinic.
- Low blood pressure is considered to be lower than 89/59mmHg or lower.

If your reading is between 120/80mmHg and 140/90mmHg, you may be at risk of developing high blood pressure in the future. There are things you can do to help prevent this:

- reduce the amount of salt you eat and have a generally healthy diet
- cut back on alcohol
- lose weight if you're overweight
- exercise regularly
- cut down on caffeine
- stop smoking

Some people with high blood pressure may also need to take one or more medicines to stop their blood pressure getting too high.

SAFETY ALERT ANKLE INJURY – "GET A GRIP"

DETAILS OF THE INCIDENT

An employee was carrying out a task using a forklift truck when he exited the cab forward facing, rather than backwards, and without maintaining three points of contact. He had placed his right hand on the grab handle and right foot on the lower step, when his right foot slipped off the step and landed on a wooden baton, twisting his right ankle.

Our colleague was taken to the local hospital, where tendon damage to his right ankle was diagnosed, resulting in a lost time injury (LTI).

KEY FINDINGS			
Supervision	No continuous supervision in the yard to reinforce the STEP IN culture whenever unsafe behaviours increase the risk of injury.		
Access & Egress of forklift truck	Need to exit fork truck backwards, maintaining three points of contact, not followed despite Operator being aware of "Get a Grip" Safety Essential.		
Safe Systems of Work	Risk assessments and safe systems of work were reviewed within the last 12 months; however, they had not been discussed with Operatives and did not highlight the risk of egressing mobile plant in a forward manner.		
Process	The production process requires the operator of the forklift truck to exit the vehicle for every lift, where there are timbers present, exposing the operator to trip hazards.		
Housekeeping	The area was clear and well maintained		

HOW COULD THIS HAVE BEEN AVOIDED

- Having adequate supervision / leadership assigned to the yard operation.
- Follow the Safety Essentials and eliminate unsafe behaviours.
- Review of production process to identify further opportunities for risk reduction.
- Position timbers in-between forklift truck wheels, eliminating trip hazards when exiting forklift truck.

KEY REVIEW POINTS

- Ensure sufficient supervision
- Share learning points with the team via a toolbox talk
- Update and communicate revised safe system of work
- Review of production processes
- Reinforce the need for everyone to follow the Safety Essentials and STEP IN if any unsafe behaviours are observed.
- Undertake a holistic review of local incident trends, considering if any common actions are identified which further reduce the potential for future injuries.

GLOBAL SAFETY ALERT

EMPLOYEE FATALLY INJURED ON RAIL TRACKS

INCIDENT DETAILS

An employee was tidying the area and cutting grass on and around the rail tracks at a cement plant. During his work, he positioned himself about 100 meters from 8 parked carts, facing away from them. A locomotive at the other end arrived with another 12 carts, which coupled those that were parked and began to move them. The last cart of that convoy of 20 then struck our employee from behind.



The employee's position when he was struck by the rail cart.

KEY FINDINGS

- Work had begun without first blocking the mechanism of the track to prevent the locomotive from entering that track and moving the rail carts.
- The employee had been assigned to clean a section of the rail track that would be free of rail cart movement, but he started cleaning an adjacent track where rail carts could move.
- The 'switchman' (guide) was responsible for checking the rear of the rail carts before they were moved, but he did not.
- The locomotive operator did not sound the whistle before starting to move the rail carts.
- The shift leader assigned the task without requesting the work permit and ensuring the safety conditions of the work area.
- There were no appropriate warning signs or a control process to alert people of a high-risk work area and to prohibit access.

MANAGERS - KEY POINTS TO CHECK

- All workers operating on railway tracks know the procedure to block the track when they perform work on it.
- All workers responsible for moving rail carts are aware of and understand the safety procedures for the activity.
- There is effective supervision in place, especially for high-risk tasks, and the correct procedures are strictly enforced.
- Permit to Work requirements are clearly defined and all supervisors and workers know their responsibilities.
- There are effective signs, signals and equipment to block the rail tracks and to alert others when work is being performed on them and when access is prohibited (e.g., 'red zones').

ALL PERSONNEL – ACTION TO TAKE

- Never place yourself in the 'line of fire'. When performing work on the rail tracks, always apply the rail track blocking procedure. Stay clear of any demarcated and prohibited areas (e.g., 'red zones').
- Don't deviate from the assigned work area unless your supervisor has agreed and always double check the new area of work is also blocked to prevent rail cart movement.
- Before working on rail activities, review whether you have had the safety training for the tasks you need to do. If in doubt, speak to your supervisor.
- Check with your supervisor to see if you need a Permit to Work for your task.
- If you have notice there are no restrictions and prohibitions in place to prevent people being in the vicinity of moving rail carts, report it to your supervisor.
