Latest UK Safety Alert



The latest UK Safety Alert shares a concern that contractors working for us on construction projects have struck buried high voltage cables on three separate occasions in the last six months while digging trenches, thankfully, there were no injuries.

The incidents occurred despite Risk Assessments, Method

Statements and Permits to Work being in place on each occasion, with shortfalls in scanning procedures and the temptation to take shortcuts amongst the contributory factors.

Buried cable strikes can lead to serious or fatal injuries. Please discuss the Safety Alert with relevant team members, ensuring they are aware of the precautions that must be taken to reduce the risk of incidents and the relevant HSE Guidance.

Thanks go to the project teams who reported these high potential (HiPo) incidents. By reporting and sharing information on high potential incidents, we can take action to minimise the potential for future injuries.

Safe Drive Stay Alive



During Road Safety Week, Cemex supported another production of the Cemex Safe Drive Stay Alive, presented in the Temple Speech Room at Rugby School on Tuesday 21st November.

With an audience of 400 students in years 12 and 13, Cemex supported the delivery of road safety messages for vulnerable road users. Shockingly, young, qualified drivers constitute only 7% of the driving population yet they are involved in a staggering 24% of all serious and fatal crashes. Equally concerning, one in six

young drivers experiences a crash within their initial two years of driving.

Safe Drive Stay Alive is a professional stage show that has been running in the UK since 2000 and is now in its fourth year in Warwickshire. The objective of this road safety initiative is to show young people why, as young drivers, they, and their passengers, are so vulnerable in their early years on the road and what they can do to reduce this vulnerability.

Lisa Greatwood, Head of Wellbeing at Rugby School, commented: "The Safe Drive Stay Alive presentation is a hugely informative, innovative and impactful way to bring home the responsibility that every driver has when on the road."



Fraud Awareness



An important message from Colin Jones, UK Security Manager

You will all be aware cyber enabled crime remains (and is always likely to remain) one of the highest security threats to our business. On this subject, unfortunately, I need to draw a series of frauds and attempted frauds to colleagues attention, each of which have taken place in recent weeks.



Whilst there is a variety of different modus operandi used, each offence was cyber enabled and there are common strands of learning.

There are several opportunities and actions we can take to minimise the threat. For customer facing colleagues in particular, I would encourage you to consider the following:

- Where a fraud or attempted fraud comes to light any associated telephone numbers (landline and mobile) and email addresses should be blocked from our systems. Colleagues can initiate this process in liaison with myself, John Sweeting or IT.
- It is important to promptly share across our business strands the details of any fraud. Two of the recent frauds were perpetrated against different supply strands within our business. The offences have commonalities which suggest the same offenders. Had we acted promptly to share the details the second offence would have been headed off easily. We can protect ourselves more effectively by communicating outside of our natural operating silos; please ensure you share details of frauds and attempts ASAP.
- The MOs used demonstrate a degree of social engineering, with some prior knowledge of our business accounts and procedures, and in particular a tendency on the offender's part to attempt to rush or bully his way through the call. Sales facing staff should maintain their professionalism throughout their call handling. Never volunteer account information and routinely always follow our procedures; they are there for yours and the organisations protection.
- Staff should be aware of the checks and balances built into our processes and discouraged from cutting corners. Specific advice includes:
 - Take your time to handle the call, do not be rushed.
 - Always carefully check email addresses. Hover above the address and ensure the link reverts to the address as it appears.
 - Any email address ending in common/generic domains such as Hotmail, Live, Gmail, Protonmail etc may give early warning to a potential fraud. Most of our accounts relate to corporate email addresses. Those that do not, should be carefully considered.
 - Take heed of the CAUTION advice, built into outlook. The advice is intended to provide early warning of a potential issue.

- Transactions that require a PO. Please remember... 'No PO.... No order!'
- Check back with ordering company via landline to confirm prices, timings and contract arrangements. Do not be rushed over the phone. This is particularly important, and again, may be a trigger issue indicating a potential fraud. Our customers are unlikely to have issue with a thorough and efficient ordering experience. In fact, in the case of a potential fraud, the offenders MO may be the result of a data issue within the genuine customers organisation. We know from experience our genuine business partners are very grateful when we are able to help them identify offences and offenders.

- Callers uncertain of their facts (email address, contact details, PO number, credit card details.... even their name) should be handled carefully. Insist on the details and do not be fobbed off: "My email address isn't working".... is not acceptable and be particularly cautious of anyone who hesitates to provide or recall their name!
- Orders via credit card need extra caution. Take only the detail the caller can provide, do not prompt or assist the caller from existing records. No more than two attempts should be accepted.
- IF IN DOUBT ADVISE THE CUSTOMER YOU WILL CALL THEM BACK AND CONSULT YOUR SUPERVISOR.

The list above is not exhaustive, and is intended to help you navigate through the potential threat of cyber enabled attempts at fraud. Maintain a calm approach and trust your gut instincts.... they are usually right.

Hybrid cars are treated as either petrol or diesel for advisory fuel rates.

Data Protection and You



As you may be aware, under the UK's data protection legislation, organisations have a duty to ensure that there are robust processes in place in terms of how they collect, store, and process "personal data" and there are serious consequence if they fail to do so.

So, what is *'Personal Data*? This is any information that relates to an identified living individual, in written or image form and includes:

- Name
- Address
- Birthday
- Marital status
- Telephone number



- E-mail address
- Physical characteristics (e.g., height, weight, hair colour)

'Special Category/Sensitive Personal Data' includes the following information about identified living individuals and this has greater legal protection:

- Race
- Ethnic background
- Political opinions
- Religious beliefs
- Trade union membership
- Genetic data
- Biometrics (where used for identification)
- Health
- Sex life or orientation

Or any combination of the above that you can use to identify someone.

In the UK protection of Personal Data is regulated by the Information Commissioner's Office (ICO) and the relevant legislation is the Data Protection Act 2018 and UK GDPR.

The consequences of breaching the rules can result in companies being liable to fines of **up to £17.5 million** or 4% of global annual turnover (whichever is the greater) for the most serious offences. There will of course also be a great deal of negative publicity associated with a breach of the rules.

At Cemex we have developed a set of detailed processes to ensure we remain compliant. We also hold ISO 27001 certification for Information Security Management.

Some key things to remember:

- 1. The legislation only covers "Personal Data" and does not include data relating to, for example, limited companies.
- 2. Please ensure that if you receive a request from an individual (whether this is an employee, contractor or member of the public) enquiring about personal data held about that person by Cemex, that this is immediately sent to <u>dataprotectionuk@cemex.com</u>. There are strict timescales under the legislation for complying with such requests.
- 3. If we are contacted by customers or suppliers about Cemex's Data Protection compliance programme and information on measures in place to protect personal data, then please forward these to <u>dataprotectionuk@cemex.com</u>.
- 4. Some customers and suppliers may insist that we enter into special agreements concerning our management of their personal data and please ensure that these are sent to the Legal Department for review. We have our own preferred agreements which should be used in such cases.



- 5. Contact the Legal Department when negotiating contracts which involve the processing of Personal Data.
- 6. Tell us about any new technology that is being developed in the UK and which involves the processing of Personal Data as we will need to carry out a Data Privacy Impact Assessment ahead of implementation. We conducted data privacy impacts on *CEMEX Go* and *icollect* ahead of these being rolled out. A Data Privacy Impact Assessment is also required when installing new or altering existing CCTV systems so please also contact us before doing this.
- 7. Do not store Personal Data on the hard drive of your Cemex computer and instead ensure this is kept securely on the Cemex network.
- 8. In the event that your Cemex mobile phone or laptop is stolen then please report this to Simon Whitfield (Process and IT Manager) and Colin Jones (Security Manager) and advise <u>dataprotectionuk@cemex.com</u> so that we can make an analysis in relation to the loss of any personal data contained on the device.
- 9. Ensure that any Personal Data retained on Cemex systems is accurate, relevant, and not excessive. All information must be held in accordance with the Cemex Information Retention Policy.



DETAILS OF THE INCIDENTS

Contractors working for us on construction projects have struck buried HV cables while digging trenches on three separate occasions in the last 6 months. In all three incidents risk assessments and method statements (RAMS), buried services plans and Permits to Work (PtW)) were in place. On the first occasion the scan with a cable avoidance tool (CAT) wasn't sufficient for the ground conditions and didn't identify the presence of the cable, in the other two cases, cables were identified by the CAT scans and were initially located by hand digging with insulated tools; however, in one case the CAT scan had identified an earthing cable, but not the HV cable below, which was struck when the trenching works continued with an excavator. In the second case, the operator decided to expose the cable at a second point using his machine, striking the cable, in contravention of the RAMS and PtW.

KEY FINDINGS				
Safe Systems	The contractors had suitable RAMS and Permits to Work; however, they were not readily available / communicated in one of the incidents, where the operator chose to deviate from safe working practices to save time and effort.			
Cable plans	Buried service plans were available but were not suitably updated in all instances.			
CAT Scanning	CAT scanning conducted improperly.			
Permit to Work	High Risk Permit does not cover breaking ground.			
Communication	Lessons learned from the incidents was not fully communicated by the contractors.			

HOW COULD THEY HAVE BEEN AVOIDED

- Correct use of Cable Avoidance Tools, in one case the tool was only used in "Power" mode, restricting its sensitivity.
- Compliance with RAMS, exposing cables at crossing points by hand
- More explicit "Permit to Dig" process with none working supervision in place.
- Additional heavier duty marking of buried services during installation.

KEY REVIEW POINTS

- Are good practices followed when installing new buried services, with 'Tile Tape' utility marking as standard for all services, accurate (DGPS) survey control, and updated records?
- Are excavations for trenches, etc. controlled under a specific Permit to Work / Permit to Dig?
- Are CAT scans carried out by specifically trained and competent personnel in accordance with good practices?
- Do we ensure close and effective direct supervision of works near buried services and other high-risk tasks?


