Latest UK Safety Alert



The latest UK Safety Alert describes an incident where an employee required three stitches to his forehead, after he was struck by a screen motor suspended from a telehandler.

There are several learning points from the incident, including:

- The requirement for thorough planning of lifting operations, with effective risk assessments, method statements and lift plans.
- The importance of relevant competence for those involved in lifting operations.
- Selection of the most appropriate lifting equipment.
- Awareness of the need to stop and reassess the method of work if a job isn't going to plan.
- Ensuring everyone keeps "Out of the Line of Fire".

Please discuss the Alert with personnel as appropriate, considering how it could have been avoided and whether there are any improvement opportunities to local arrangements to reduce the potential for future injuries.

Cemex welcomes the updated BS8500



On Thursday 30th November the UK construction industry welcomed the long-awaited update to the British Standard for concrete – BS8500.

The British Standards Institute (BSI) is introducing an updated version of the British Standard for concrete, to provide even greater options for concrete and cement manufacture, in the critical area of reducing the embodied carbon.

BS8500 will increase the options of specifying lower-carbon concretes for our diverse customer base, providing greater availability, selection and choice across our entire portfolio, without compromising on performance.

For specifiers of our products, in simple terms, BS 8500 will now allow the specification of ternary cements (cements and combinations containing three main constituents instead of just the two allowed up until now) and mixer combinations. This means that CEMII/A-L (a type of cement that incorporates between 6-20% limestone, reducing the portion of clinker and subsequently the embodied CO₂) and GGBS (Ground Granulated Blast-furnace Slag), can be combined in a wider range of exposure classes, and in the future, when they are made available, factory produced ternary composite cements.

The amended concrete standard will serve to keep us on track with our decarbonisation goals, with the primary objective to become a net-zero CO₂ company by 2050. It also aligns with our Future in Action programme, to achieve sustainable excellence through climate action, circularity, and natural resource management.

The amendment to BS8500 strongly supports our ambitious global goal for Vertua lower-carbon cement and concrete products to reach half of all cement and concrete sales by 2025. As the first company to introduce net-zero CO_2 concrete in 2020, we have the ongoing responsibility to deliver lower carbon products at scale.

BS8500 was discussed at length last week at the Cemex UK Readymix Commercial Conference, where key stakeholders across the Cemex business received updates on how the update will impact their respective business areas. We will continue to keep you updated with further BS8500 updates from across the business as they become available.

In the meantime, the MPA has provided a webinar which provides information on the main revisions to the standard and how the method of specification has changed to facilitate the wider range of lower carbon concretes that will be available.

Damon Montgomery closed the event with a positive reminder that being a strong team, with excellent people, they will weather the forthcoming challenges successfully together.

Lex Russell, Managing Director Materials UK, commented: "It was fantastic to see our Readymix Commercial teams all together again. We shared some excellent business updates and some valuable social time to catch up with colleagues as well as meet new ones. The commercial team can be very proud of their performance over the last 12 months and it was a pleasure for me to be able to thank everyone in person. Many thanks to all of our presenters, Marcuss and Damon for organising the conference and to everyone for taking part in the open and varied discussions."

100th train to Parkfield

Friday 1st December marked the 100th train into Parkfield Rd since its first train on 1st August. You can read all about the Parkfield Road Restoration Project here.

So far we have safely accepted and offloaded 160,000 tonnes of spoil which has removed approximately 8,000 trucks from the road. Using trains

brings significant CO₂ savings by removing trucks off the roads. By using alternative transports methods demonstrates Cemex's Future in Action commitment to net zero CO₂ by 2050.

This has only been achieved with the close cooperation between Operations, Supply Chain Rail Team and Commercial colleagues. Well done to everyone involved.

Looking for spare parts for your plants?

Did you know that Cemex UK owns a large secure warehouse in Mansfield, fully stocked with spare parts for our Cemex plant equipment.

The warehouse is operated by Jason Sparrow from our UK Procurement team and has now been open for one year. So if you are responsible for ordering spare parts for any of our sites/plants/quarries or wharfs, get in touch with Jason to see if he can help – before going to an external supplier.

Service levels are very good, with deliveries normally next-day if the items are on the shelf. The warehouse is also directly linked to our Reliability Centred Maintenance strategy, which many operations managers are enrolled in for Q4 2023 and into 2024.

Cemex Lifestyle – rebranding from Sodexo to Pluxee

Have you had your flu jab yet?

With temperatures dropping as we go into October, why not be prepared by going and getting your flu jab?

Flu is an unpredictable virus that can cause mild or unpleasant illness in most people. It can cause severe illness and even death among vulnerable groups including older people, pregnant women and people with an underlying health condition.



Over time, protection from the injected flu vaccine gradually decreases and flu strains often change. So new flu vaccines are produced each year which is why people advised to have the flu jab need it every year too.





So, now is the time of year when people are advised to have a vaccination jab to help protect from or reduce the symptoms of flu. Some people in the higher risk categories get the immunisation free via the NHS. For others the jab is widely available through local pharmacies or local GPs.

As usual, Cemex will reimburse the cost of the vaccination for those that are not entitled to a free jab. Just provide your Line Manager with an itemised receipt and they will arrange for you to be reimbursed the cost of up to a maximum of £20.

Flu jab side effects

Serious side effects of the injected flu vaccine are very rare. You may have a mild fever and aching muscles for a couple of days after having the jab, and your arm may be a bit sore where you were injected.

There is also evidence to suggest that the flu jab can reduce your risk of having a stroke.

As well as flu vaccinations, you should make sure all your 'jabs' are up to date; not only those you had as a child, but if you are planning to travel abroad. Ask your doctor which vaccines are right for you.



DETAILS OF THE INCIDENTS

The motor on a mobile screen on a Wharf was leaking hydraulic oil. The Wharf Foreman was asked to remove the motor prior to the attendance of contractors, to allow them to fit another motor from consignment stock; a task that had been carried out on previous occasions. The Foreman had been advised to get assistance from a Site Operative. The weight of the motor was supported by a telehandler. The incident occurred when the final bolt was released from the motor. As the motor was pulled back, it snagged on the torque plate brace. The Operative tried to release the snag and the motor freed and then, because it was attached to strops suspended from the telehandler, it rotated anti clockwise hitting the Operative's safety helmet, which pushed into his forehead causing a laceration. The motor continued to rotate, with the torque plate striking the right-hand side of the Operative's nose. He was taken to hospital where he required 3 stitches.

KEY FINDINGS				
Safe Systems	There was no specific Risk Assessment, Method Statement (RAMS) or Lifting Plan for the activity.			
Lifting	There were lifting certificates for the strop and telehandler.			
Isolations	Manager in Charge Isolation padlocks and tags were in place on the mobile screen isolator.			
Take 5	Undertaken before commencing the activity by both the Foreman and Operative.			
Communication	The two staff were communicating through the open telehandler window.			
Personal Protective Equipment (PPE)	Both person were wearing full PPE.			


HOW COULD THEY HAVE BEEN AVOIDED

- Specific RAMS and Lift Plan should have been in place to identify the most appropriate method of work, and ensure when the task didn't go to plan, it was stopped allowing the RAMS and Take 5 to be reviewed.
- The weight of the motor was being supported by a strop wrapped around the motor attached to the telehandler. The Foreman operating the telehandler and Operative were communicating through an open window. Use of a Hiab may have improved communication and allowed the person guiding the lift to stand on the work platform; alternatively, use of a pull lift would have provided greater control of the tension placed on the motor.
- Rather than attempting to release the motor by hand, use of a guide rope would have avoided the need to be "in the line of fire".

KEY REVIEW POINTS

- Safe Systems Is there sufficient planning of activities, with RAMS, lifting plans, etc. in place before work starts?
- Management of Change If a task isn't going to plan, do we stop and reassess the method of work?
- **Competence** Is everyone involved in lifting operations competent for the work? The Operative had only been in position for 6 months.
- **Tools / Equipment** Do we always use the right tools / equipment for the task?







KEEP SAFE THIS CHRISTMAS



- Where appropriate, ensure company cash is banked prior to the holiday and not taken home for safe keeping or left in the safe.
 If an onsite safe is otherwise empty, leave the door obviously ajar.
- Ensure all windows and doors are closed and locked. Lights and electric heaters are turned off unless there is a pressing reason for leaving them or lights are part of the night time security measures.
- Any site, mobile plant and vehicle keys are preferably taken off site or suitably secured preferably in a safe.
- Safe keys are taken home and not hidden.
 Site radios and chargers should be hidden or locked in the safe.
- Gate and office keys should not be hidden outside. If an authorised member of staff needs access to the site they should take a key with them.
- For CCTV sites monitored at Coventry, ensure your key holders are notified to the control room (ukcctv.security@cemex.com).
- Per usual practice, staff on site during the holidays must notify the control room when they enter and leave the site. Failure may result in the police or key holder being called.
- The Coventry CCTV Control Room will be staffed throughout the holidays, from 1800hrs Friday 22/12/22 to 0600hrs Tuesday 2/1/23. (Tel: 01788 517377)
- Where possible, valuable personal possessions and tools should be taken off site, (they are not covered by the Company insurance) including, personal possessions in trucks and company car.

- Laptop computers should not be left in car boots or behind the back seat. This applies at all times, especially if socialising after work or visiting the shops or gym on the way home.
- If you have gas oil or fuel tanks on site, leave as little as possible in the tank, and don't get a delivery just prior to the holiday. Move any bowsers into as secure a location as possible and secure any containers (water cannisters, ad mixtures containers etc..) and wheelbarrows that could be utilised to carry away syphoned fuel. If containers are not otherwise recyclable, consider puncturing to prevent misuse.
- Vehicles, trucks, and mixers...leave as little fuel in as possible. If able to do so move vehicles off unmonitored sites. Vehicles left on site should be parked tank-to-tank or battery-to-battery to frustrate offender access.
- Take steps to bury and protect all cabling and other copper assets. Cabling not in use should not be stored on site.
- If an intruder alarm is fitted to a building make sure it is set and operates correctly. If the gate is secured by a combination padlock ensure that Coventry CCTV office has the correct code (ukcctv.security@cemex.com).
